- **Information Committee** Vistas was the big item discussed at meeting. For profit entities who rent facilities, how much coverage they get in the vistas news article. Only one entitie charges and that is yoga. Also working on updating welcome packet.
- Road Committee- No quorum so no business was met. 2 community members attended. Went over fall road inspection. Road inspection happen twice a year, once in the spring and oonce in the fall.
- **Stable Committee** September 30th will be the next meeting. Billing was sent out, biggest issue is stable owners who own the barn but do not maintain them.
- Environmental Advisory Ad Hoc Committee- will be working on a system to better inform the public about news that needs to get out. The intent of the committee and board is to use no pesticides at all. Working on putting out a list of pesticides/herbacides that are safer. Avenger is being used to do weed treatment.

Open Forum

- Joe Lowey, 6 Monterey Rd: Spoke about water leak at the stables and how GM Julie
 Navarro and her husband went out there after hours, capped 2 of the 3 lines and called
 vendors waiting for them to arrive. Julie called 3 vendors before 1 told us they would show
 up the next morning. Amelia was great and informed the stable owners of the water being
 turned off and if anyone needed to get water to let her know and she will get them some.
 Joe Loewy wanted to publicly acknowledge Julie and Amelia for the work they did to
 ensure this situation is taken care of.
- Jon D'Amore, 16 Tarro Rd: Received verbal apology from GM Julie Navarro. Jon appreciates the apology. Spoke about how Russell Winslow was upset with him and apologized the next day. Spoke about how the vice president misquoted him but like a gentlemen stood up and apologized. Spoke about how David had to be reminded to

- apologize. Says that we are trying to make him the example of the civility policy. Told everyone that in the mail he got another another award from a congressmen.
