Based on a consultation with Susan Tweit, plant biologist and owner of Barn #5, the team will pursue the following actions as the next phase:
 - o Encourage and good drought resistant and sustainable native plants, thus reducing weeds
 - o Encourage grazing of edible weeds and work to eradicate non-palatable weeds
 - o Educate people about weeds
