**1.** No one was present to offer public comment.

- 2. The Proposed Agenda was adopted, modifying an incorrect reference to the 2015 Budget to 2016.
- 3. The Draft Minutes from 11116/15 were approved without changes
- 4. General Manager Brenda Leonard reported that security cameras at Compadres Park were awaiting better weather for installation; cameras at the Community Center and stables were installed and operating. The Auditor/Tax Preparer schedule has been agreed to by involved parties. The GM inspected repair work along with Lee Onstott from the Facilities & Grounds Committee, and saw multiple examples of unacceptable work; the GM will see that this is corrected before payment is made to contractor AFJ. There is still an issue with server E-mail backups and how well desktop client backups preserve e-mail. The assessment invoices will be mailed immediately after the first of the new year, and will include a two-page cover letter with a summary of the 2016 budget and reference to details available on the web site or at the office.
- 5. Treasurer/Board Liaison Todd Handy reported that the Board is interested in further details on capital, replacement, and maintenance/supply costs for Dog Pet Stations along the hike/bike paths. ECIA is receiving more stables payments than we have recognized revenue for--confusion on when billing was done in 2015 and for what will be corrected for 2016. Todd will check with our insurance agent and attorney to arrange proper reimbursement for insured expenses defending a solar lawsuit.
- 6. There were no unusual items in the Financial Reports.
- 7. The 2016 Budget Operating Contingency item for HOAMCO direct hire of all ECIA employees was reduced to \$13K upon HOAMCO's assurances that New Mexico Gross Receipts Tax would not need to be collected on employee salaries. The revised 2016 Budget and Budget Message have been posted to the web site and are available in printed form at the office, ready for Board adoption at their 12/17 meeting.
