Old Business:

1. **UBL # 2-07-06, Caroline Bauer, 13 Dovela Road**, with plans for a Small Accessory Structure

These plans are approved with the stipulation that the roof material shall be of an Earth toned color and not reflective.

New Business

2. **UBL #3-49-07, Michelle Halloran, 7 Lauro Road**, with plans for a Large Accessory Structure and fence. These plans were approved with the stipulation that the color red of the roof

shall be one of the acceptable Eldorado approved colors and of low reflectivity.

3. **UBL #31216, Mike Saladin, 12 Carlito Road, with plans for an all wood pergola.** These Plans were approved with no stipulations.

4. **UBL #3-52-14, Carol Tyroler, 1 Lujo Place, with plans for a new Home addition.**
These plans were approved with stipulations that the color red of the roof shall be one of the approved metal roofing colors and of low reflectivity. As well the new widows shall match the color and style of the exiting home.

5. **UBL# 1-46-12. Jim Nichols, 7 Redondo Court,** with plans for 70 sq. ft. small Accessory structure attached to home. The shed will be attached to the garage. The Stipulation attached to this approval is that the green roof shall be one of the acceptable Eldorado approved colors and of low reflectivity.

6. **UBL # 3-25-10, Brad Masopust, 17 Verano Loop,** with plans for a Coyote Enclosure fence. These plans were tabled due to the fact that there was an older fence on the property that when included would make the total enclosure much more the max allowed 4000 square feet, and further research was required on this issue.

Further Business:

1. There was discussion on the new home on Birla Court that was of a Northern NM Design and the Committee assured the resident that the plans were approved and that The roof color was compliant.
2. The Committee discussed the status of the 25 foot Count side setback issue and decided

That we should proceed with trying to meet with our County Commissioner, Ed Moreno, To initiate the process of trying to get a county overlay zone for Eldorado, so that it is the agrees with the Eldorado 20 foot side and rear setback. Mark will initiate a meeting with Ed Moreno and Katherine Mortimer and Joe Gutiérrez on this matter.

3. The Committee discussed whether the HOAMCO Architectural Software Program would be beneficial for the ECIA. It was pointed out by Mark and Kathrine that having residents Involved in the process was important in Eldorado and allowed for transparency and Community input. Mark will further research this matter with HOAMCO to see how customizable it is and if it meshes with our existing Caliber Database and report back to the Committee.

FINAL ORDER OF BUSINESS:

The Committee discussed the need to accept a resignation of a non-active member and Melicent agreed to have the Board take up this matter at the May Board Meeting. Additionally, it was pointed out that a new prospective member was attending the meeting and he will send a letter of intent and his resume to the ECIA.
