## The Goats Are Coming

he ECIA Board, aided by the Conservation Committee, is pleased to announce the return of the goats who graze the brush and weeds along some of our greenbelts. The primary reason for this activity is to mitigate fire danger during this very dry year.

The areas where grazing will occur include the Gallina Park: from the clubhouse to the Compadres Children's Park, the Pueblo Canon Park: west of rail trail, east of Avenida De Compadres, west of power lines in the larger sections of that park, and if time allows, in both Los Alamos Parks: west of Avenida Torreon to Rail Trail. Greenbelt maps are available at the ECIA office or on

the Eldorado website **elsoradosf.org** at **http://www.eldora-dosf.org/images/home\_owners/greenbelt\_map\_2014.pdf**.

Ms. **Amanita Thorpe's** herd of goats will be supervised at all times, and all efforts will be made to prevent them from straying onto private property. **If you do not want goats to possibly stray onto your property,** please contact the ECIA office (466-4248) to obtain yellow tape to mark your property's boundary with the greenbelt or contact the office about any concerns.

The goats will be arriving in April, subject to good weather, and will be grazing for approximately one month.

## Library Trail Restoration 2018

The ECIA Conservation Committee is sponsoring a greenbelt trail restoration/repair project in 2018 on the trail that connects the Senior Center to the Monte Alto Road (map on the next page).

This trail will match the section that was restored in 2016 between Avenida Torreon and Melado Drive. Work will be done to correct erosion problems and to widen the trail to allow folks to walk side-by-side. The brush will also be cleared to reduce the fire danger, and Cholla removed to keep Cholla burrs off the trail.

Our original intent was to improve the trails that access the

Senior Center Library and Eldorado School but this is County property, and the County has not responded to our requests for trail improvement that we submitted over two years ago.

The old trail encroached on private land, and we have made every effort to reroute to the trail to ECIA land only. The areas where the reroutes will go are flagged with red flags, while areas where there will be no change, are not flagged. We have found and flagged some lot markers to aid us, but in case we have erred, we would appreciate those whose property neighbors the trail inform us of any problems. **Continued on next page.**





## Message from the Board

n November 20, 2017, the board approved the creation of an Ad-Hoc Environmental Advisory Committee to review the ECIA Integrated Pest Management (IPM) policy. Antone Forneris and I are the board liaisons to the committee whose charge is to develop environmentally sound guidelines for pesticide use, maintenance, and new construction, and to set up procedures for an ongoing review of all ECIA practices that impact the environment.

The current policy was adopted almost 20 years ago and was in need of updating and strengthening, so the committee will be developing a more detailed, comprehensive IPM policy. In the meantime, we are recommending an extensive review and community notification policy to the board to ensure that residents are aware of the details of any proposed pesticide application well in advance.

In conjunction with the facilities and grounds committee, the Environmental Advisory Committee is in the process of reviewing the proposed tree removal around the pool to see if there is an

alternative to using an herbicide to kill the roots.

The board has requested a new proposal to only cut down the tangle of three trees at the pool backwash and to not treat the roots until the backwash system has been evaluated for repair or replacement. The committees will be meeting together at 3:00 pm on April 4 to further discuss the issue.

The committee would like to see the ECIA become an environmental stewardship role model for residents by developing policies that promote responsible use and protection of the natural environment through conservation and sustainable practices.

The committee meets on the 1st Tuesday of every month at 3:00 pm in the Conference Room at the ECIA offices - our next meeting is April 3rd. We welcome residents to attend and are currently looking for additional committee members. Applicants must be members in good standing and current on all assessments.

## Jumpin' Right In

s you might be shocked to learn, our pool amenity is probably in the area of 280 years old—in dog years, that is. It's been around since 1977. In mid-2017, the ECIA Board established an ad hoc group of regular pool users, working with the facilities and grounds committee (F&G), with the explicit purpose of providing an evaluation of our existing pool facilities and guidance on where we might want to go with it from here. Members of this group include Jean Crawford, Mike Schneider, Martha Jackson Deutsch, Ted Freedman, and Mary Ellen Donat. Their F&G liaison is Russell Winslow as seen below:



One of the concerns is the well-being of the pool's infrastructure. If it is in significant decline, either a major rehabilitation or a replacement would be in order. In either of those two scenarios, all pool appurtenances would have to comply with existing standards. If the pool needs to be replaced, we'll want to build a new facility that will meet the requirements and visions of the next generation or two of pool users. Even if the pool is found not to be in significant decline, we need to provide the proper levels of maintenance and operation to ensure we continue in operation, without midseason interruptions, for the next several years.

The Pool ad hoc group was tasked with three major undertakings:

- 1. Determine the best vendor to do a structural engineering study of the pool and environs to provide an objective "comfort level" about the remaining life of the pool;
- 2. Provide an in-depth (pardon the pun) evaluation of pool operations, designed to improve the pool experience going forward; and,
- 3. Identify the most basic work needed to be performed to open the pool on time and keep the pool open during the 2018 pool season. Continued on Page 8.



## Rattlesnake Avoidance Clinics for Dogs

Tith the warm temperatures, it will not be long before dormant creatures return to our landscape, including rattlesnakes. To help protect our canine friends, the Central New Mexico Brittany Club (CNMBC) is hosting, for the fifth consecutive year, our annual Rattlesnake Avoidance Clinics for Dogs on Saturday, April 21 on the grounds of the ECIA Community Center and Sunday, on the West Mesa, Rio Rancho. Terry and Janet Chandler, of Las Cruces, will again conduct these clinics, held on the hour, beginning at 8 am.

Checking with staff at both the Eldorado Animal Clinic and Cedarwood Veterinary Clinic, dogs with rattlesnake bites in 2017 were about the same as in 2016. Cameron Veterinary Clinic staff reported that there were more than last year. Recall that all of these clinics reported an increase in 2016 over 2015 rattlesnake incidents.

Two participants from Eldorado, who attended with their dogs in 2017, reported that they had run-ins with their dogs and rattlers after the clinic. **Claire Bruno** and her dog, Aspen came



across two rattlers within ten days. The first in the Eldorado Community Preserve and the second in Galisteo Basin Preserve. Aspen demonstrated the same avoidance behavior as she did during the clinic. This alerted Claire to the presentence of the rattlesnakes, keeping both hikes safe for all. As Claire said, Aspen "swept" the area of rattlers.

**Felice Cohen** wrote that her dog Brodie saw a rattlesnake last summer on their portal and jumped back, way back, which alerted her to the viper's presence. County Animal Control arrived and hauled the four-footer away. Felice is bringing her new rescue dog, Riley, to this year's clinic.

## Fighting to Save the Galisteo Basin Preserve

ate last month, The Santa Fe New Mexican published a front-page story and editorial urging community members, government officials, and donors to rally in defense of the Galisteo Basin Preserve (GBP). Citing the preserve's extraordinary cultural, ecological, scenic and recreational values, the article and editorial served as a call-to-action for the community to ensure this well-loved, actively-used open space and trails network is permanently protected.

Hobbled by a deep and protracted recession, Commonweal Conservancy's vision to forge a new model of environmentally responsible development and large-scale land conservation proved impossible to achieve. Burdened by pre-recession debt totaling more than \$5.4 million, Los Alamos National Bank (LANB) launched a foreclosure suit last year that threatens the loss of more than 10 miles of publicly-accessible trails, and large lot residential development within the interior of the GPB open space.

Over the past year, Commonweal has attempted to negotiate a settlement agreement with LANB that would allow the organization to pay off a measurable portion of the organization's debt in exchange for a release of its promissory notes. If an agreement could be reached, Commonweal has been poised to launch a fundraising campaign that would leverage donations from major donors, Santa Fe County and members of the greater Santa Fe community to relinquish the bank's claims.

To date, unfortunately, those negotiations have proven unsuccessful

If LANB's foreclosure runs its course, the bank will take title to approximately 3,500 acres of partially developable, partially conserved property west of the GBP trailheads this summer. A subsequent sale of the property could result in the development of 12-14 large estates within the interior of the preserve, and public trail access could be restricted. By developing GBP's interior land, miles of new roads could be constructed, wildlife corridors fragmented, and a significant portion of a beloved community recreation and open space resource lost.

Despite the challenges and uncertainty that have dogged the organization since the start of the recession, Commonweal remains deeply committed to the GBP's permanent protection. If an agreement can be reached to settle LANB's claims in the month ahead, open space and trails enthusiasts in Santa Fe and surrounding communities will be invited to help support the preserve's permanent protection through Commonweal's anticipated fundraising campaign. As the organization presses forward in its efforts, know the support of Eldorado residents and members of the larger Galisteo Basin community is strongly felt and appreciated.

## **Summer RV Courtesy**

ith summer just around the corner and with Santa Fe being a major summer tourist destination, Eldorado residents are frequently visited by family and friends who often arrive in their RV's and end up parking in their driveways and on their lots. When this occurs, we often hear from neighbors who are concerned that their next-door neighbor has purchased an RV and has not submitted a screening plan for it.

While the ECIA covenants do not address visiting RV's on a lot, they do address RV's on a lot under Article II, Section 13 of the covenants. This section is detailed as follows:

Section 13. Storage and Screening of Vehicles and their Accessories. a) Recreational vehicles, such as motor homes, RVs, campers, camper shells, vehicle accessories, trailers, horse trailers, airplanes, boats and the like, when stored on a lot shall be located so as to minimize their visual impact on the surrounding neighborhood and roads, and shall be obscured by screening in a reasonable manner, for example by the dwelling house and/or with plantings or fencing. No more than three such vehicles shall be stored outside on any lot at any time. No more than one additional vehicle shall be parked temporarily on a lot for a period not to exceed three weeks. This paragraph shall be applicable to recreational vehicle accessories, such as camper shells and the like.

With this being the case, three weeks can be a long time for a neighbor to have to look at an unscreened RV, owned by

a non-resident. Because of this, we encourage residents not to allow their visitors to park their RV's on their lot for more than a couple weeks and encourage them to park in the area that least impacts your neighbors. Additionally, we encourage all



residents to notify their neighbors, as well as the ECIA, when a visiting RV is going to be on their lot.

Please include the anticipated date of arrival and departure dates of the RV, as well as where it will be parked on the lot. This small gesture will likely result in much happier neighbors and will help eliminate extra work for the ECIA staff as we will then know what RV's are owned by visitors and not lot owners. ## **Spiders**

FLORA AND FAUNA

any people react strongly to spiders. Some shriek in fear when they see one. Others are convinced it's bad luck to kill them. Many of us think they're incredibly interesting. It's fascinating to watch big Orb Weavers spin their magic and build nests, Wolf Spiders on an agile hunt, quick Wall Jumpers and clever Crab Spiders. It's great that spiders don't carry diseases, and they rid our homes of flies and mosquitoes.

We especially appreciate our tarantulas, gentle giants of the spider world, harmless to humans. In the fall – especially in September around here – you will find male tarantulas "migrating." That means they are leaving their burrows to seek out a mate. Drivers need to be careful to avoid them!

Although all spiders can bite if cornered or handled, spider bites are rare; often "spider bites" are in fact rashes, thorn wounds, infections, or bites from other insects. There are only two local spiders considered dangerous: Widows (brown and black) and Recluses.

The Western Black Widow is glossy black, with a red hourglass on its abdomen. The Brown Widow can be cream to dark brown and has an orange or yellow hourglass. The female Widow is the dangerous one. Like all spiders, they are





not aggressive but will bite if threatened. Bites feel like a pinprick followed by pain, burning, swelling, and redness.

There are several species of Recluse Spiders in the Southwest. Often called fiddleback or violin (due to the violin-shaped mark on their back), Recluses are tan or brown. Again, they won't bite unless you handle or startle them. Bites cause a mild stinging followed by strong pain and redness that can turn into a dark ulcer.

Widow and Recluse bites are rarely fatal. But if you think you've been bitten by one, don't delay in seeking emergency treatment.

Common-sense precautions are to avoid spider bites as well as other hazards: Dust and vacuum homes regularly, keep debris to a minimum, never stack wood near homes, always wear gloves when working outside. And keep a close eye on your children and companion animals.

## **Bath Water Reuse**

here are lots of reasons we have chosen Eldorado as a great place to live. A cheap, endless supply of water isn't one of them. In our home, when we shower or bathe, we pump our water into four 5-gallon containers which are then carried outside to water our plants and trees. 3-gallon containers have the advantage of being easier to carry and to store. A third option is to run a longer hose to an outside rain barrel.

Please note, "greywater" should not be used on plants/trees bearing fruits or vegetables used for human consumption.

The sump pump we chose is from Amazon (part number B000HOT3YI) and attached six feet of an old garden hose. Cost \$57. It will pump the water out down to about a quarter of an inch.

You may choose the cheaper route and purchase a pond pump such as Amazon part number B071D9P1SF (\$16) along with tubing such as Amazon part number LPpvc075-010ft (\$19). The downside is the pump will only suck the water down only to about an inch and a half.

To use, simply place the pump in the bathtub water. Put the hose in the container and then plug in the pump. When the container is almost full, you can kink the hose to move it to the next container without dripping. Unplug the pump when the water in the bathtub is so low that the pump starts sucking in air. We don't have a problem with the sump pump scratching the bottom of the tub, but if this is a concern, you can get self-adhesive rubber feet from the hardware store. If you choose to use a pond pump suction may be an issue; you may need to slit two or more of the rubber feet if they grip the tub too strongly. Instead of removing the plug from the outlet to turn the pump off, you may choose to use an in-line switch like Amazon part number B01894YMX4 or a combination switch/receptacle like Amazon part number B00880BCQ0.

We store our pump/hose under the bathroom sink in a dishpan, so we don't cause water stains on the cabinet floor.

Of course, you do not want to reuse bathwater used by a person with an infectious disease. If you choose an external rain barrel, you are supposed to distribute the water within 24 hours. These undertakings are now in progress, and we look forward to the implementation of the findings. It is not expected that any work recommended by the pool consultant will be started until after the 2018 pool season, nor during pool seasons in the next two or three years. To ensure there will be ample funding to cover the unknown future costs of keeping the pool open, the board decided to incorporate a reserve account which, over the next four years, will help defray whatever costs we may encounter. The first chunk of this reserve fund will be taken out of this year's assessment and the rest over the next three years.

As you use the pool this coming season, you may wish to follow the example of our Pool ad hoc group—it's safer to jump in than dive in.
