Keeping Eldorado Special *No Small Task*

I dorado is more than just another development. It is a special way of life increasingly

ment. It is a special way of life increasingly dependent on its residents for the thought and work it needs to survive as a unique place to live.

Many communities in America today lack a sense

Many communities in America today lack a sense of roots and cohesiveness. Some are no more than bedroom communities where residents have little feeling of belonging or involvement. By volunteering and getting involved, the residents of Eldorado have countered this trend. Eldorado is a unique place. It has a rich treasure of diversity and a high average educational level. Our residents represent a wide variety of professional skills. We rightly boast of having a larger artist colony than many communities with that designation.

The phrase Vista Grande, the name of Eldorado's key avenue, was not the product of a zealous real estate developer. Our home was known as an area of spectacular views long before the developers saw potential profit here in the late 1960s. Eldorado sits in the middle of one of the most interesting and geologically diverse areas of the planet. The prominent hills that straddle both sides of Route 285 mark the southern end of the Rocky Mountains. Looking south you see the combined crags of the San Pedro and Ortiz mountain ranges. To the southwest is Sandia Crest, the mountain that flanks Albuquerque. The small array of hills in the foreground is Los Cerrillos - 'The Little Hills' - a perfect little mountain range that gives us such pleasure. On a clear day, in the far distance, we can see Mount Taylor near Grants. On our western horizon sits the huge bulk of the Jemez Mountains. A million and a half years ago – just yesterday in geologic time – one of the volcanoes that formed the Jemez erupted. The explosion spewed forth a volume of ash estimated to be 150 times greater than that ejected by Mt. St. Helens during its most recent eruption. There has

been speculation that if no development had occurred here, our area may have become a national monument or national park.


The planners who shaped Eldorado had to have been more than just real estate developers. They sold the original buyers "a residential community...where the natural environment, open spaces and vistas would be preserved...where coherent architectural designs of the homes built would blend into the beautiful landscape, where there would be a unique and sustainable quality of life."*


All of the above is why the ECIA exists and why its Architectural Review Committee works hard to ensure our homes are, in the language of the original residents, 'Nava Ade' - belonging to the land. It is why the ECIA enforcement officer works hard to ensure we can enjoy the brilliance of the starry sky by keeping the night sky free of light pollution. In order to keep our incredible views, the ECIA will soon publish clear guidelines on Recreational Vehicles (RVs), trailers of all types, boats and sheds. It's all about keeping our stunning views intact and "living lightly on the land." Our homes, by blending with the environment, keep a low profile as they follow the architectural styles that developed here. Anything we introduce into our habitat, anything we put beside our homes, can detract from our view and spoil the effect the majority of us seek to maintain.

Many believe Eldorado is one of the greatest places to live in the United States. Through the hard work of volunteers and residents like you, we can work together to keep Eldorado special.

THE ARGUMENT THAT BIG BUSI-NESS assuming ownership of our water utility will be detrimental does not make sense. The assumption that a company will cause loss of service is not true. What about other utilities such as PNM? We do not own them yet they provide a service based on market conditions. The same will be true if the "Dutch" company assumes ownership. Water and other utilities are heavily regulated. They can't raise rates or change other conditions without first going through the PRC. What has AMREP (American Real Estate and Petroleum Inc.) done for us other than provide a service? The same will hold true for any other entity that assumes ownership. Self ownership will result in tax increases that most will not be willing to bear.

When I turn the tap on, I expect water. I see no reason this will not happen with outside ownership.

HAT TO DO ABOUT OUR WATER UTILITY? Should we sit back and allow the for-profit, shareholder corporation —Utilities Inc./Nuon (UI/N)—run it or control it ourselves?

It seems clear UI/N must first satisfy its shareholders. Logically that means an increase in water rates and number of new customers hooked up to the system, placing an increasing strain on our fragile water supply. It is unlikely we could save enough to allow for UI/N's future expansion.

If we acquire the utility, we (the voters) control what happens. We elect the water board from community members whose primary motivation is the economic health of our community. Initially we will see a small increase in property taxes; the money will go to acquiring and improving the utility.

The decision seems clear. We should control our own destiny! I will vote yes in the General Obligation Bond Election and urge my neighbors to do the same.

WOULD LIKE TO WEIGH IN on the acquisition of the water utility. In my consulting experience (management consulting for water districts). I have found there is no connection between the desires of the communities and those of the private water companies. In addition, private firms did not maintain their infrastructure.

In order to both provide water service that reflected the public's desires and maintain the infrastructure, most communities took over the systems. Just like Eldorado is proposing.

In the area of my practice, every well managed water district was a public district. The service was much better and more responsive than private purveyors, and almost always at measurably less cost over the long run.

I will cast my vote for condemnation. I believe we can have control over the system, better service, and significantly lower costs. The people of Eldorado are perfectly competent to elect a board dedicated to servicing the community.

Community College Survey Results

THE RESULTS ARE IN from the recent Santa Fe Community College survey regarding classes in Eldorado. Only 18 people responded to the survey. The majority of the respondents would prefer to take non-credit classes. Schedule preferences are evenly split between weekdays vs. weekend classes with a lesser preference for weekend classes. The requested class subjects include computer courses, Spanish, writing, and pho-

tography/digital imaging/media arts.

Eldorado by Design

Architectural Committee's Bill Schwent

HERE IS A RUMOR that **Bill Schwent**, Chair of the ECIA Architectural Committee, knows every one of Eldorado's over 2500 houses personally and can recite each one's builder and details from memory. "Not really true," laughs Bill. "But over the years I've probably been in 60% or 70% of the houses in Eldoradoboth in my business as a realtor and with the Architectural Committee."

Bill has gone from flying a helicopter gunship during the Vietnam Tet Offensive to piloting the ECIA Architectural Committee. He has been active on the Committee since the early 80s when architectural control passed from AMREP (American Real Estate and Petroleum Inc.), developer of Eldorado, to the community. Bill has served as Chair twice during the last decade. "It's always been easy to get volunteers for the Committee. People like to see the results of their work, and those who serve on the Architectural Committee can see our results all around us."

The Architectural Committee deals not merely with plans for complete new houses, but requests for fences, walls, sheds, and additions of all sorts - 30 or more projects per month. ECIA Covenants call for a decision on a proposed project within 30 days. In order to meet this requirement, the Architectural

Committee meets twice a month - currently on the second and fourth Tuesday evenings. Committee members include architects, developers, and contractors, as well as knowledgeable and interested lay people. When necessary, the eight members will schedule additional meetings for site reviews, special project reviews, and planning.

Bill grew up south of St. Louis, Missouri, and majored in Business

Administration at the University of Missouri. In 1979, after Army service in Vietnam and Germany, he came to Santa Fe to visit his college roommate. "My roommate was from Santa Fe" Bill says, "and his love of the area motivated my visit. We went into business together, and I've never left."

Bill worked for a time with Rational Alternatives, a builder emphasizing solar homes, which ultimately developed several hundred lots in Eldorado. Bill liked what he saw and moved to Eldorado in the early 80s. "Most of the solar homes were standard designs," he remembers. "Once the builder started accepting custom orders, it became more difficult to match good solar practices with the changes that prospective owners wanted."

Bill became active with the ECIA soon after moving to Eldorado and served five years on the Board. "The Santa Fe area is a great place for volunteerism," he comments. "Not everyone is interested in community affairs, but those who serve community organizations free up others to work on schools, churches, charities, and youth activities."

Bill takes a relaxed attitude toward all the meetings he attends. "If someone comes with an attitude or a gripe, meetings can be a real drag for them. But if you come looking for great cheap entertainment, then you will find it. And you always learn something—always!"

Cerrillos Hills Our 'Vista Grande'

LDORADO HAS ONE OF THE BEST views there is of the Cerrillos Hills. Look to the southwest. See the half-dozen conical peaks about eight miles away? There may be more history per square inch in those little hills than anywhere else in New Mexico.

For more than a thousand years the hills have been important to our area. First the hills yielded turquoise for New Mexicans and all of the Southwest. Later the lead used to glaze Indian pottery was found there. Still later Spanish silver was mined in the hills. 1879 saw a boom-miners swarmed the hills while building rough-and-tumble camps named Hungry Gulch, Poverty Hollow, and Carbonateville. A few years later the boom was bust and the settlements were ruins—all except for Cerrillos Station, the camp along the newly arrived railroad.

Two years ago, with the encouragement of the volunteers of the Cerrillos Hills Park Coalition, the Santa Fe County Open Space Initiative set aside 1100 acres of these hills as the Cerrillos Hills



Historic Park. The park is still under development. An archaeological survey has been completed, trails are under construction, and the park awaits the safety treatments for the nearly 100 hazardous old mineshafts (including some with grates for bats). By this time next year you'll be able to see for yourself. The Cerrillos Hills Historic Park is expected to open to the public in the spring of 2003.

Homeland Security

Neighborhood Watch Committee Forming

CROSS THE NATION, including northern New Mexico, Neighborhood Watch is ▲ becoming a vital part of formal disaster plans and informal networks for less serious situations. Eldorado is the largest unincorporated area in New Mexico. Because we do not have public safety officials dedicated to Eldorado, we must be somewhat self-sufficient as the Santa Fe County Sheriff's office is seriously short-staffed. In some areas of Eldorado, neighbors have informal arrangements to watch vacant homes, care for pets and plants, and bring in mail when others are gone. Eldorado's new Neighborhood Watch Committee wants to increase the level of involvement.

During the afternoon and early morning hours of May 7 and 8, Eldorado had no working communication systems outside of our community. We had no outside phone service, 911, internet or cell phone access. This issue and other factors, such as our location along the WIPP route, prompted ECIA staff to consider the need for better communication and

organization between neighbors. The result is the new Neighborhood Watch Committee.

With guidance from Santa Fe County **Emergency** Management and National Neighborhood Watch, the committee is taking steps to bring Eldorado closer together. Neighborhood Watch will continue to serve as a deterrent to crime —such as burglary and vandalism—but will expand its mission.
