WATER MATTERS PART 1 Common Concerns Encourage Community A SHORT HISTORY OF THE ELDORADO AREA WATER AND SANITATION DISTRICT **WATER MATTERS**

ow servicing nearly 3,000 homes and businesses, the 18-year-old Eldorado Area Water and Sanitation District (EAWSD) is publically owned by property owners within the district. However, the water utility now administered by the district came into public ownership just over a decade ago. Ratepayer ownership of the system through the district was only accomplished by years of hard work on the part of individuals and a great deal of community cooperation.

Carved from the former 27,000-acre Simpson Ranch in 1970, Eldorado was developed by a New Jersey-based corporation, American Real Estate and Petroleum Corporation (AMREP). In order to obtain the right to develop Eldorado's 6,000 acres, AMREP was required by various state and county agencies to build and maintain a water system to serve the subdivision. A subsidiary of AMREP, Eldorado Utilities, Inc. (EUI), was created for this purpose. CONTINUED ON PAGE 3 >>

Home Maintenance Projects Needing ECIA Approval

ne of the more problematic covenant violation issues that we face as the Homeowners Association of Eldorado at Santa Fe occurs when residents begin home repair projects without realizing that the project requires the approval of the ECIA.

The most common of these infractions involves restucco work. A resident who fails to seek ECIA approval but uses a noncompliant stucco color could possibly be required to restucco again, this time with a compliant stucco color—at a significant cost to the homeowner.

We at the ECIA would like to remind all residents that any *permanent exterior* modifications or improvements require the approval of the ECIA Architecture Committee. This includes additions such as garages, sheds, walls, fences, cisterns, and solar arrays—in fact, any structures that are permanent in nature.

In addition, even some minor home improvement projects may require approval if they involve the exterior of buildings on a lot. Among the many types of projects that require ECIA approval are:

- Replacing any exterior doors or windows
- Repairing or repainting exterior walls
- Adding awnings or shade devices
- Adding driveway monuments
- Changing or modifying existing fencing

- Adding garden enclosures or greenhouses
- ▼ Changing exterior lighting

While these projects may seem small, the fact that they involve permanent structures, or entail changes visible in the neighborhood, means that they will likely require Architecture Committee approval. Note that certain projects, such as restuccoing with an approved Eldorado stucco color, can be approved by the ECIA staff rather than the committee, provided the required applications are brought to the ECIA.

If you are a homeowner and have a project in mind, we ask that you call me, Mark Young, at the ECIA at 466-4248 to see if your project requires Architecture Committee review. I will gladly work with you to ensure that you have the required forms filled out properly, so as to streamline the review and approval process. Residents may pick up the application forms at the ECIA office or can download the Architectural Plan Form from the Eldorado website at www.eldoradosf.org. As well, residents can review the most current Eldorado Covenants and Guidelines for Protective Covenants and Building Restrictions on the website.

Recent Board Actions

the ECIA Board held its regular monthly meeting on July 16, 2015. Four Board members were present: Dag Ryen (President, presiding), Todd Handy (Treasurer), Greg Colello (Secretary), and Antone Forneris. Jeanne Calzada, Pam Henline (Vice President), and David Yard were absent, excused. The following formal actions were taken unanimously, with the Chair voting:

- The Board appointed Antone Forneris as a Director to fill a vacant term expiring in May 2018.
- ▼ The Board approved a variance for 86 Verano Loop for an existing fence and shed, previously approved in 1993 but not constructed according to plan, to extend 5 feet into the required 20-foot side setback.
- The Board approved a Home Profession application for 31 Monte Alto Road for a custom furniture workshop, pending county approval.

- ▼ The Board approved a Home Profession application for 37 Verano Loop for an existing environmental studies business.
- ▼ The Board appointed Eduardo Krasilovsky and Gershon Siegel to the Information Committee.

Regular Board meetings are scheduled on the third Thursday of each month at 7 PM at the Community Center and are open to the public. The next Board meeting will be on August 20. In addition, the Board holds an informal (no votes) Board working session in the Community Center Conference Room at 6 PM on the Monday before the third Thursday of each month. EUI began laying pipes between the existing ranch wells and individual lots, and installing storage tanks. EUI would later add to the system by drilling more wells.

The Public Service Commission had required that AMREP subsidize its operations until Eldorado was at least 80% built out. In the early 1960s, AMREP had likewise been required to build a water utility system for its development of Rio Rancho, northwest of Albuquerque. With the creation of Eldorado at Santa Fe, AMREP, primarily a land sales company, now found itself with two water systems on its hands.

By the late 1980s, AMREP was anxious to sell off both the Rio Rancho and the Eldorado water utilities. It found a potential buyer in General Waterworks, a French-owned company. However, the EUI subsidization agreement killed the package deal, and General Waterworks bought only the Rio Rancho system.

In 1992, realizing that EUI could be sold at any moment, the ECIA began a series of community forums regarding the utility's future. At that point, the system was estimated to be worth around \$3 million. Many in the community thought that was a reasonable amount and believed that creating a water and sanitation district was a first step toward purchasing the utility.

Without a district, there would be no entity capable of entering into negotiations with AMREP should the community decide to purchase EUI. However, there was little community enthusiasm, and the idea languished until 1994, when AMREP's subsidization of EUI was no longer required. Suddenly EUI customers began to see significant increases in their bills.

It was then that the Eldorado Residents' Association (ERA) in cooperation with ECIA revived the water issue. The two organizations set up a joint water study committee. However, residents from surrounding subdivisions also serviced by EUI showed an interest in the effort. At that point, an area-wide independent Ad Hoc Water Study Committee was created and included residents from many Eldorado-adjacent subdivisions.

The committee's year-long work resulted in its recommendation to create a water and sanitation district and to purchase the water utility. That's when the real work began. The committee now had to convince at least 25% of the taxpaying electors in the proposed district to sign a petition in favor of forming the district.

In early July 1996, the Santa Fe County Commissioners voted unanimously to accept and certify the petition submitted by 390 Eldorado area residents requesting an election to form a water and sanitation district. A year later, on July 1, 1997, out of the approximately 1,100 eligible voters, 427 said "yes" and 55 said "no" to creating the district. Ray Nichols, Don Dayton, and Dick Chenault were elected to that first district board to two-, four-, and six-year terms, respectively.

That board notified AMREP of the district's interest in acquiring the utility and initiated an engineering study to see what exactly they might be acquiring. By then,



August 12, 13: Perseids Meteor Shower. The Perseids is one of the best meteor showers to observe, producing up to 60 meteors per hour at its peak. It is produced by comet Swift-Tuttle, which was discovered in 1862. The Perseids are famous for producing a large number of bright meteors. The shower runs annually from July 17 to August 24. It peaks this year on the night of August 12 and the morning of August 13. The thin crescent moon will be no match for the bright Perseids this year, so be prepared for a great show. Best viewing will be from a dark location after midnight. Meteors will radiate from the constellation Perseus, but can appear anywhere in the sky.

August 29: Full Moon, Supermoon. The Moon will be located on the opposite side of the Earth as the Sun and its face will be fully illuminated. This is the first of three supermoons for 2015. The Moon will be at its closest approach to the Earth and may look slightly larger and brighter than usual.

wo years ago a group of volunteers started to plan. With the support of the ECIA Facilities and Grounds Committee, and with backing from the ECIA Board, a multi-year project was put together to save the dying landscape at the Eldorado Community Center. Much work has been done in the last few years to that purpose: a new xeric cactus garden, rock mulching, lighting, and other beautifying and water-wise projects.

Landscaping the "island" is part of the multi-year project that began with the recognized need to care for existing mature trees, and then grew into a plan to restore the Community Center grounds to a healthy, high-desert landscape. We are making use of the existing installed cistern system, channeling runoff from the paved surfaces, and using manure compost from the horse stables. The work has been done almost exclusively by ECIA staff and a few dedicated volunteers—an example of Eldorado at its best.

This project is well on its way to becoming an Eldorado Community Park. In addition to xeric shrubs and buffalo grass, we are planting trees such as honey locusts and autumn ash and offering them to the Eldorado public in a "Commemorative Tree Program." This program will also include shade trees and large juniper trees to be located in the open area on the north end of the park. Anyone wishing to remember someone or commemorate an event with a tree can purchase one in the landscape plan for only \$295. Carved stone plaques are available for purchase as well, to be placed with the trees. Information on the commemorative tree and bench project is available at the ECIA office.

Trees bought in the next two months will be planted this fall. As of this writing, there are only 12 trees left! Please consider investing in this wonderful community project.

Former ECIA Board Director Siegel Reflects



s a candidate running for the Board last year, I stated that one of my goals was "to help reinvigorate a spirit of cooperation within Eldorado." Yes, there were philosophical differences among us during my 12-month tenure. And yet, the Board enjoyed a collegial spirit. At times we stretched from our positions to obtain an ongoing consensus on most all issues.

It's no secret that my decision to run for the Board in the first place was to help voice a perspective on a particular issue. To many ECIA members, including myself, a long dispute over covenant interpretation seemed harmful to the community. I sought to bring balance.

Also as a candidate, I naively believed we could move past what I then termed "managing by lawsuit." Unfortunately, the lawsuit brought some years ago by the Association toward residents over backyard hen keeping continues in the courts. The lower court found in favor of ECIA, but the defendants have appealed that decision. I had hoped we could move toward less adversarial ways of resolving our differences. To date, between the ECIA and the defendants, more than \$100,000 in legal fees has been spent on the matter.

Another of my candidate-statements was: "I know we can overcome the constraints that an HOA tends to place on a community when it comes to running itself democratically." That was wishful thinking on my part. As a 24-year-resident, I've experienced numerous times when community building has taken a backseat to fiduciary duties and covenant enforcement.

Everyone on the Board during my tenure was decent and well intentioned. Still, the ECIA is charged with enforcing 40-year-old covenants never designed to encourage an evolving, sustainable community. New Jersey lawyers created our covenants to facilitate selling nearly three thousand lots carved from a New Mexico cattle ranch. At times I felt conflicted sitting on the Board. Board members find themselves choosing between protecting the business end of Eldorado and protecting an individual's right to adapt to changing times.

My last candidate statement was that "we have a membership that recognizes sustainability as a front burner issue and is ready to deal with it." Was that naive as well? In 1991, People Magazine proclaimed Eldorado "the largest passive solar community in the nation." Yet, we have a number of residents who believe solar panels are fine as long as they stay on roofs and can't be seen.

Ironically, the ECIA is currently in litigation over this very issue. A resident has sued the Association for permitting ground-based solar installations. While the district court found in ECIA's favor, ruling that state statute prohibits the Association from placing undue burdens on residents who seek to utilize their solar rights, the decision has been appealed.

While my goals as a candidate didn't match up with my achievements as a Board member, I'm still hopeful for my community of 24 years. My wish is that these costly and unnecessary lawsuits get Eldorado to recognize sustainability as a front-burner issue. Perhaps our "city of gold," in its own strange way, is finding its silver lining.

The Amazing Raven

re've always felt lucky to live among ravens - their size and sleek beauty make them a real presence in the community. Recent research confirms how special these animals are.

Similar in behavior to crows but larger and with thicker bills, ravens are highly intelligent—as smart as chimpanzees and dolphins. Like other intelligent species, nearly a decade is required for a raven to reach full intelligence. They live an average of 17 years in the wild and up to 40 years in captivity. These amazing animals can remember a person's face, and they can relay knowledge about that person to other ravens. They solve problems by studying situations to determine a course of action, and they use tools (such as a stick to probe for food in small places) more effectively than chimpanzees. If a raven knows another raven is watching, it will pretend to hide food in one location when in fact hiding it elsewhere (but since the other raven is likewise smart, this trick doesn't always work!). Sometimes working in pairs, one raven will distract an animal while the other raven steals the animal's food. Ravens have a large vocabulary, with regional dialects and accents. Some have been known to mimic human speech. U.S. military experts have studied their potential use in spy-like functions.

The raven is featured in stories throughout human history. Native Americans considered the raven an honored cultural champion, known for heroism and great deeds, even involved in the creation of the world—but also known as a trickster who causes problems because of his enjoyment of pranks. Celtic goddesses of warfare took the form of ravens during battle. Odin, the Viking god, had two magical companion ravens. In the Middle Ages, people came to fear the birds because, being scavengers as well as hunters, ravens were seen to eat off corpses from bubonic

plague. Edgar Allan Poe's famous poem "The Raven" immortalized the bird with its repetition of "nevermore." In current times, artists celebrate the raven's beauty, and we recognize ravens' helpful contributions to our environment (the average small family of these birds eats over 10,000 bugs per month!).

A flock of ravens is called an "unkindness," but nothing can be further from the truth. Ravens can be very playful, frolicking like puppies, soaring and swooping, rolling around in snow, sliding down slippery hills, playing keep-away, and even using toys (sticks, golf balls, rocks) to play with each other. Although they sometimes taunt other creatures for amusement, they can also be shy and cautious. Young, unmated ravens roost together at night, sometimes in very large groups. Ravens mate for life, and if an area is too densely populated with other ravens, the grown "kids" will stay with the parents to help raise any final young. During breeding seasons, raven parents will use water (frequently in bird baths) to soften food-sometimes body parts of small animals-before taking it to their hatchlings. Ravens demonstrate friendships and empathy. When a raven dies, its family members gather and exhibit grieving behavior by walking past the dead bird, dropping sticks or straws by the body, making noise as a group, and then flying silently away.

The next time a raven flies overhead, say hello to this remarkable animal.

however, AMREP believed that the leaky, barely adequate EUI was now worth about three times the original estimation. Negotiations for the utility's purchase between the district and AMREP stalled.

In July 2001, EUI was allowed a 42% rate increase. On top of that, AMREP was about to sell the water system to Utilities Inc. (UI), a subsidiary of Nuon, a Dutch multinational energy and water company. Nuon already owned hundreds of other small water systems throughout the world. The community became embroiled over the controversy of a foreign corporation owning the local water system. Globalization had arrived in Eldorado.

The district responded to the imminent sale of the utility by commissioning a financial analysis of the system and surveying homeowners serviced by EUI. Of 900 responses from area residents, 58% concurred that the district should proceed with the acquisition. Voters approved a bond issue in August 2002 that enabled the district to purchase the system.

By February 2003, since an agreement on the utility's sale had already been completed between AMREP and UI, the district was forced to kill the deal by "condemning" the system. In September 2004, a jury trial was held to determine the purchase price-\$11.047 million. As a result, EAWSD, through the condemnation process allowed by its "quasi-governmental" status, acquired the water system as a public utility. In addition to owning the system, EAWSD also bears the debt load for the purchase price.


