Preventing Wildfires

Ithough there is no standard agreed upon definition of the wildland—urban interface (or WUI, as fire agencies call it), it is loosely defined as "homes or structures built near or among lands prone to wildland fire." Under that most basic definition, all of us served by the El Dorado Fire and Rescue Service (EFRS) live in the WUI. Some portions of the El Dorado Fire District are officially designated as wildland—urban interface areas by Santa Fe County Ordinance. This reality, coupled with numerous years of drought in the Southwestern United States, means that we are at risk for wildland fire. What has EFRS done to prepare for this possibility, and what can you do?

Over the past five years, EFRS has made a significant financial and preparedness commitment to plan for a wildland fire event, including:

- ▼ In 2009, we purchased the first Type 3, "heavy" wildland engine in the Santa Fe area. A heavy engine is larger, carries more water, and has more crew capacity.
- ▼ In 2013, we purchased a second heavy wildland engine. This apparatus is also a class A pumper that can be used for structural firefighting. This dual-purpose apparatus is also the first of its kind in the Santa Fe area.
- ▼ In 2014, we purchased a "tactical water tender" which can be used to both haul and apply water in wildland fire scenarios.
- ▼ In 2014, we purchased a replacement Type 6, wildland fire engine. This apparatus can be used for quick attack and to get in areas where larger vehicles cannot operate.

- ▼ For the last several years, we have encouraged our members to train for wildland fire events and acquire national certifications in wildland firefighting.
- Finally, we strengthened our working relationships with neighboring fire departments in responding to and fighting wildland fires anywhere in the area.

The El Dorado Fire and Rescue Service now maintains the largest fleet of wildland firefighting equipment in Santa Fe County. We can deliver more than 4,000 gallons of water and a crew of 13 firefighters to any wildland incident in the district.

Most wildland fire events are caused by humans or lightning. Be careful not to spark a wildland fire by careless use of smoking materials or outdoor fires. If you see smoke, call 9-1-1 immediately and don't assume someone else has done so. Catching a wildland fire early is the best way to keep it small. Store firewood and other combustible materials a safe distance from your home. Maintain a defensible space around your home. Defensible space is defined as 30 to 100 feet of soil free from vegetation. Trim trees and other vegetation 10 to 15 feet away from your home. Remove branches from the lower portion of trees so that a wildland fire traveling along the ground will not ignite the larger vegetation.

Even small steps can help protect you and your home. If you would like EFRS to conduct a wildland survey of your property, call 466-1204 for an appointment. Call that same number if you would like to join our wildland firefighting team or assist in providing other emergency services to the Eldorado community.

Mission

The mission of Vistas, the monthly newsletter of the ECIA, is to inform the Eldorado community about issues before the ECIA Board and the membership at large. By so doing, the publication seeks to foster increased neighborhood pride and community participation in the decision making process.

The Secure Facts

t a recent ECIA Board meeting, a number of residents voiced concern over the potential loss of "Eldorado Security." One resident asked the important question, "What is Eldorado Security and what does it do?" Yet another and equally important question is "How much does Eldorado Security cost?"

Currently, the community's security consists of a contract with ASI Security, the activities of our Community Services Manager, and IHS Alarm Services. The purpose of all three is to ensure security of the "common properties" that are owned by all lot owners: the Community Center complex, Compadres Park, the Stables, and the parking lot trailheads.

Neither ASI Security nor the Community Services Manager is invested with Peace Officer powers. They may not trespass onto private property, do not work 24 hours a day, seven days a week, or on holidays. The Community Services Manager also performs other tasks that are not related to security.

ECIA's annual cost for Eldorado security is approximately \$115,000. This figure excludes IHS alarm monitoring and miscellaneous costs associated with our Community Services Manager. Recently ASI Security has projected increases in their fees.

Following a break-in at the Community Center this past Thanksgiving holiday, the Board developed a working group to look into improving the overall physical security of our common properties. A plan was agreed upon that would use technology to provide for 24/7 security coverage. The one-time cost for these technology upgrades was approximately \$20,000.

The ECIA Board has not yet settled on a complete, final plan regarding Eldorado's security. There are many factors to consider, not the least of which is a possible savings to the lot owners of approximately \$500,000 over a five-year period.

The Board is aware that there are some misconceptions about ECIA's security efforts. To dispel these and to replace a possibly false sense of security with the actual facts concerning our security measures, please consider the following:

- ▼ First and foremost, neither the ECIA nor ASI provides security for residents and their property. The sole purpose of our paid security operations is to ensure the security of the common properties.
- Scheduled house checks by request of homeowners have not been provided in Eldorado for several years. This practice ceased after both ASI and ECIA attorneys advised against this practice due to potentially extensive liabilities. (At a recent annual ECIA Board of Directors Ethics and Finance Training, the Board was again reminded that providing security for residents is an ill-advised policy that is considered to be one of the top ten poor business practices that should be avoided by all HOAs.)
- A strong Neighborhood Watch Program, coupled with a clear understanding of personal safety habits and home alarm services, are among the most vital factors in assuring personal resident safety. Should you find yourself in need of police, fire, or other emergency assistance, the only number you need to know is 911! Seeking assistance elsewhere by any other means will only put unnecessary time and distance between you and responsible, professional help.

The extensive savings incurred by recommended changes to how security is addressed in Eldorado, in concert with greater awareness of the facts regarding security, will give us both a safer community overall and a healthier financial bottom line. The ECIA Board will host a town hall meeting on Monday, September 8, from 7 to 9 PM at La Tienda, at which residents are encouraged to voice any questions and concerns they may have regarding this important quality of life and safety issue in our community.

Greenbelt Trail Work

n 2014, the ECIA Board asked the Conservation Committee to consider improvements to the 👤 greenbelt trails. Many residents had stopped using these trails because they were practically unwalkable, having become V-shaped from use and erosion.

The committee embarked on a pilot project to assess how a well-constructed greenbelt trail will perform. We expect it will take several years for us to determine how sustainable an improved trail will be. Currently we have constructed 1.7 miles of 2.3 miles planned in Pueblo Canyon between the train tracks and Avenida de Compadres. The work is ongoing along the whole trail. We are building unobtrusive erosion mitigation structures and seeding the embankments with grass to reduce the current width to the desired 4 feet. (For further details, see eldoradosf.org.)

The ECIA Board is holding a town forum on Monday September 8, from 7 to 9 PM, where residents can express constructive views. The Committee plans an open house in October to explain the purpose and methods used to construct the improved trail.

The ECIA is working to bring more of its activities and information online and to make better use of modern technology. There has been considerable unauthorized activity—for instance, at the far end of Camino Valle, which parallels the interstate across from Avenida Amistad. Members are reminded that they should only use the four designated trailheads to gain access to our preserve trails.

Finally, the Board would like to remind everyone to take extra care when traveling around the community this fall as the daylight hours shrink. Joggers, bikers, and children on their way to school are often difficult to see in the morning and evening light. Let's make this a safe season in Eldorado.

Recent Board Actions

The ECIA Board held its regular meeting on July 17, 2014, with all seven Board members present: Dag Ryen (President), Pam Henline (Vice President), Greg Colello, Gershon Siegel (Secretary), Todd Handy (Treasurer), Jeanne Calzada, and David Yard. The following formal actions were taken unanimously, without the Chair voting, unless otherwise noted:

- ▼ President Ryen apologized for two pool closures this season and noted that they may have been due to power surges; also that staff was doing all they could to keep the pool open and that the pool season may be extended due to these recent closures.
- ▼ President Ryen noted that the search for a new general manager is moving forward.
- ▼ In response to a question regarding poultry litigation, it was noted that poultry owners have filed an appeal to the judge's decision that ECIA Covenants prohibit poultry; the ECIA has requested an appeal bond.
- A home business application was denied for 1 Joya Court for an animal boarding facility.
- ▼ A motion to approve a new Road Committee charter was withdrawn.
- ▼ A motion to withdraw the ECIA-owned 2 La Hacienda Loop house from rental use was approved.
- ▼ Tara Debevec was appointed to the Stable Committee.
- A variance was approved for 31 Moya Loop for an 8-foot-high fence, where the Guideline height is 6 feet, for RV screening, with conditions.

- ▼ A variance was tabled for 2 Moya Place for T-111 siding on the back of a carport, pending a Board site visit
- ▼ The ECIA Employee Manual was amended to make Holiday Pay conform to the minimum required by state law. (5-1, Calzada opposed)
- ▼ The use of employee compensating time was curtailed, and existing balances are to be used by the end of 2014.
- Revised instructions were accepted for Nominating Petitions for Director positions expiring May 7, 2018, as recommended by the Elections Committee.

The ECIA Board held its regular meeting on August 21, 2014, with six Board members present: Director Colello was absent. The following formal actions were taken unanimously, without the Chair voting, unless otherwise noted:

- ▼ A variance was approved for 5 Sandia Lane for a metal roof element 2% above allowed coverage.
- ▼ A Home Occupation was approved for 18 Abanico Road for private yoga lessons.
- ▼ A variance was approved for 4 Rico Court for an 8 foot high RV screening fence.
- ▼ A variance was approved for 21 Juego Road for a fence encroaching 19 feet into the 50-foot front setback, encroachment to be removed when house is sold (4-0-1)
- A variance was denied for 1 Altura Road for driveway access off Monte Alto Road.



The Hole Truth

friend was anxious to eliminate gophers from her property. She positioned a hose into a hole and blasted it with water. Unfortunately, it turned out that the gopher was long gone but a family of rabbits had moved into the abandoned burrow. The woman felt terrible that she had drowned the baby rabbits.

Sometimes it seems like our properties are full of holes-small holes, big holes, holes with mounds, holes under trees. Although we know it's best to leave most of the holes alone (as the majority of the critters who dig holes won't do us or our property any harm), we can't always identify which animals created which holes. So we decided to dig (pun intended!) into the truth of the matter by conducting some basic research.

We found some surprising information. Most holes do not indicate gophers. Many of the animals who build the holes are beneficial to the ecology. And you can't always assume the animal who built the hole is the one actually living in it!

Animals typically dig holes to hide their young and/or to take shelter from predators and bad weather. In general, holes 3 inches or smaller were made by chipmunks, ground squirrels, or rats, those larger than 3 inches by badgers, coyotes, fox, or prairie dogs.

Chipmunk holes are clean and neat, silver-dollar sized. Spotted Squirrel holes, which do not include a mound, are typically 2 inches in diameter, located under rocks or shrubs. Rats (kangaroo rat, aka pack rat or wood rat) build complex dens with several chambers.

Badger holes (unusual in Eldorado but we do have them) are about a foot wide, with a mound of dirt in front. The holes are shallow, although when a female is preparing to give birth, the hole will be deeper. Coyotes typically do not use dens except on occasion. Foxes will often use another animal's hole but can dig their own when needed. Prairie dogs live in large colonies with multiple holes; the dirt around the hole is higher than the entrance.

Gophers are skillful diggers. It's important to note that gophers generally do not leave visible holes! They create extensive underground tunnels, often making large mounds. When finished digging for food, gophers usually plug up their hole with dirt or vegetation.

Most North American rabbits don't make holes. Instead, they dig a shallow hollow in the ground near plants such as low junipers or sagebrush. In winter, the rabbits might use tunnels in the snow as a place to rest.

It's important for us to remember that other animals might use existing holes. Some birds, rabbits, and snakes use vacated holes, for protection from predators or bad weather or to shelter from the sun. Tarantulas, spotted ground squirrels, burrowing owls, and rabbits—as the neighbor in the account above found outcan be found in burrows made by other creatures. Sadly, many residents inadvertently kill the wrong animals by targeting a particular type of hole.

Senior Center News


