# County Schedules Eldorado Projects

anta Fe County included a number of Eldorado projects in its FY 2013-2016 Capital Improvement Plan. The projects are divided between "Quick Start" projects funded by gross receipt taxes to begin immediately and General Obligation Bond projects that are subject to voter approval in the November elections.

#### "QUICK START" GROSS RECEIPT TAX **PROJECTS**

- 1. \$1.5 million for construction of an addition to the Vista Grande Library
- 2. \$150,000 for design and construction of an addition to the Adam Senior Center, plus \$850,000 for an attached new Community Center
- 3. An additional joint-use parking area as a part of the above projects

The new Community Center would be for use by Eldorado residents as well as County residents living outside of Eldorado. It would also be utilized as an election voting site, County field office, and to hold county-wide meetings.

#### **GENERAL OBLIGATION BOND PROJECTS**

- 1. \$900,000 for Herrada Road paving
- 2. \$194,000 for Avenida Amistad paving
- 3. \$91,000 for Avenida Buena Ventura paving
- 4. \$2.5 million for Rancho Viejo-Eldorado water pipeline

Although not specific to Eldorado, the County Commission agreed to put three questions on the ballot of the November general election regarding countywide general obligation bond proposals:

- 1. \$19 million for roads
- 2. \$10 million for water & wastewater projects
- 3. \$6 million for open space, parks, and trails

#### **FUTURE COUNTY IMPROVEMENT PLANS**

On August 29, the County Public Works Department met with county residents at the Adam Senior Center to solicit proposals for future development projects. These proposals will be included in a future County Capital Improvement Planning Project Overview for consideration by the County Commission. The state legislature may also be asked to furnish funding for certain projects.

#### PROPOSED COUNTY FIRE PROTECTION **EXCISE TAX**

The County Fire Department has proposed that unincorporated county residents be given the opportunity to vote on renewal of a Fire Protection Excise tax in the November elections. This would impose a 0.25% tax on all non-medical/non-food items (25 cents on a \$100 purchase) in unincorporated areas of the county. Funds raised through the tax would be used for the capital purchases (principally apparatus, large equipment, and facilities) of the Santa Fe County Fire Department and its 32 fire stations and would provide an estimated \$1.24 million annually. An earlier fire excise tax (which had been in effect since 1985) expired in 2008, but if renewed could become a permanent annual tax.

The primary sources of funding for the El Dorado Fire and Rescue Service (EFRS)—an all-volunteer fire department whose personnel receive no salaries but contribute many thousands of hours annually to help insure the safety and well-being of the community are the State Fire Protection Fund and impact fees. The State Fire Fund consists of monies collected by the State of New Mexico from fire insurance premiums, which are distributed as grants to fire departments throughout the state. Impact fees are one-time assessments on building construction projects within the various Santa Fe County fire districts to help offset the cost of providing emergency services in developing areas. With the slowdown in construction, these fees have been minimal the last several years and have declined by 75% since 2008.

Although the El Dorado Fire Department is better funded than most fire districts in Santa Fe County, it is very difficult to pay all of the day-to-day costs of running a fire department and to set aside funds to replace apparatus, maintain the buildings, and purchase or upgrade large equipment such as rescue tools, protective clothing, wildland firefighting

### Recent Board Actions

The ECIA Board held its regular meeting on August 16, with Board members Ed Moreno (President), Pat Lavengood (Secretary), Jeanne Calzada, and Jan Deligans present, along with 11 residents. The following formal actions were taken unanimously, unless otherwise noted:

- ▼ Nolan Zisman and Paul Jacobs were appointed to fill vacancies on the Board.
- Alice Griffin and Karen Cameron were appointed to the Stable Committee.
- **▼ Joe Durlak** was appointed to the Sustainability, Planning and Education Committee.
- ▼ Jan Pietrzak's appointment as Parliamentarian was amended to end in June 2013.
- A variance was approved for 3 Duende Road for a solar array 100 feet from the house, where Guidelines call for 15 feet, to reduce visibility to neighbors, with screening vegetation.
- ▼ A variance was approved for 12 Enebro Road, for an existing retaining wall within the required 20foot rear setback, for erosion control.

A variance was approved for 114 Verano Loop for a solar array 95 feet from the house, where Guidelines call for 15 feet, to reduce visibility to neighbors, with screening vegetation.

The meeting was adjourned to executive session to discuss legal matters.

A special Board meeting was held on August 23. All Board members were present, with one resident. The following actions were taken unanimously:

- The Board voted to set the Date of Record for the covenant vote as August 23, 2012.
- ▼ The last date for covenant ballots was set at October 1, 2012, with votes to be counted on that date.
- ▼ The ballot language was approved for a covenant

Board meetings are scheduled on the third Thursday of each month at 7 PM at the Community Center, and are open to the public. An open forum, community announcements, and reports from ECIA committees are regularly included. # Chicken Covenant Vote Closes Oct. 1

very member of the ECIA has been mailed a ballot on the question of homeowners keep-✓ing hens on their properties. The voting will continue until 2 PM on Monday, October 1, when the ECIA Election Committee will commence to count the ballots.

Any homeowner or lot owner who has not received a ballot should immediately contact the ECIA office to obtain a replacement ballot.

The ballot has two choices. Amendment A (Chickens Allowed) would allow residents to keep a limited number of hens as pets. Amendment B (Chickens Prohibited) would prohibit residents from keeping any animals that cannot live inside the house, and itemizes prohibited animals. Lot owners may vote for one of the two amendments.

The ballot was developed by the Ad-Hoc Covenant and Survey Drafting Committee, and was amended and approved by the Board on August 23.

The ECIA covenants allow amendment of the covenants pursuant to Article IV, Section 1, of the Amended and Restated Protective Covenants and Building Restrictions for Eldorado at Santa Fe. The section states: "The ECIA ... reserves the right to amend these covenants ... provided that the ... owners of a majority of the lots covered (by the covenants) consent to such amendments." As of August 23, 2012, the Date of Record for establishing eligibility to vote, there were 2,777 eligible lot owners. To amend the covenant, at least 1,389 lot owners must consent to either one of the amendments. Each lot owner must cast his or her vote for only one of the amendments. Mismarked ballots will be disqualified. WE ENCOURAGE ALL ELIGIBLE LOT OWNERS TO VOTE!

The text of the proposed amendments is specified on the ballots. You can also find the exact language on our website, eldoradosf.org.

# Need Architectural Committee Approval?

ne of the more problematic covenant violations we face at the ECIA occurs when residents undertake home repair projects without realizing that their project requires the approval of the ECIA Architectural Committee.

The most common of these infractions is re-stucco work. Residents should be aware that use of a noncompliant stucco color without ECIA approval can result in being required to go back and re-stucco the home with a compliant stucco color, at a significant cost to the homeowner.

We at the ECIA would like to remind all residents that any permanent exterior modifications or improvements will require the approval of the Architectural Committee. This includes additions such as garages, sheds, walls, fences, cisterns, solar arrays, and any other structures that are permanent in nature.

In addition, many home improvement projects that involve the exterior of the buildings on a lot may, even if minor, require architectural approval. A partial list of the many types of minor projects that require ECIA approval include:

- Replacing any exterior doors or windows
- Adding awnings or shade devices
- Adding driveway monuments
- ▼ Changing or modifying existing fencing on the lot
- ▼ Repairing an existing fence but changing the height, size, or method of construction

▼ Adding above-ground raised gardens or garden enclosures.

If you have a home improvement project in mind, we ask that you call me, Covenant Compliance Representative **Mark Young**, at the ECIA at 466-4248 to see if your project will require Architectural Committee review. I will work with you to ensure that you have the required forms filled out properly, to streamline the review and approval process. Residents may pick up the forms at the ECIA offices or can download the Architectural Committee Submission Form from the Eldorado website at eldoradosf.org. There are no fees for this consultation and approval process.

#### **Reel New Mexico for October**



# At the Crossroads

ur roads are in as good a shape as they've been in several years. While some have the usual (for this time of year) washboarding, the rest are smooth (for dirt roads). Even though we missed the usual rainfall, what we did have was just enough to help, along with the grader, keep washboard to a minimum. We can help to keep them that way by adhering to (or driving below) the speed limit.

Please be aware that the upcoming November election will have a County bond issue on the ballot. If it passes, we can (finally) expect paving of Avenida Amistad from Avenida del Monte Alto to Avenida Buena Ventura; Avenida Buena Ventura; and Herrada Road. Your votes will help decide this important issue.

This column will be my last as chair of the Road Committee. Having recently been appointed to the ECIA Board of Directors, I must relinquish my seats on three committees. I must say that my time on the Road Committee has been particularly gratifying. # New Trail 105 in Eldorado Preserve

The idea of a flat trail in the Preserve was proposed by hikers, cyclists, and horse riders. Ideally, the trail would be rapidly cleared of snow or ice by the winter sun so that it would be usable in all seasons. This idea led the members of the Conservation Committee to investigate a possible corridor for such a trail that would require a minimum of trail work. The obvious choice was the southern boundary of the Trail 100 portion of the ECIA Preserve land. The trail would begin at the Trail 100 parking lot and join Trail 101 near the 301 junction.

After several outings with the committee and some local equestrians, a path for the trail was defined. Most of the trail would be flat, but two large arroyos needed to be crossed. Eagle Scout candidates Jim Rose and Matt Rohr chose to develop the two difficult portions of the trail as their Eagle Scout projects.

In August and September, Jim and Matt (respectively) directed friends, family, fellow scouts, Conservation Committee members, and Eldorado residents in defining and clearing each portion of the trail. The trail was designed in concert with Jan Willem **Jansens** of Ecotone, the Conservation Committee, and the candidates. Issues to be considered included minimizing erosion and making the trail appealing to all. Jim Rose organized a crew of about 30 people who toiled in the hot sun to make the project a success. Matt planned a similar effort. The trail will be officially opened in October but can be hiked or ridden before that time. The Conservation Committee is working on a new updated map that will show the exact location of this trail. We hope that the new trail will increase the enjoyment of our valuable Preserve.

# Eldoradio 1660

T nside a Herrada Road home flying international flags is one of Eldorado's best-kept, most pleasant L secrets. It is an unlicensed but legal low-power radio station. The station's studio is located in the home of **Bill Dunning** and his wife, **Ann**, who have lived in Eldorado for about 12 years. Bill, who operates the station, has been a Santa Fe resident since the early 1970s.

The station can be found at 1660 on the AM dial. You can hear it throughout most of Eldorado on a car radio, if not at home. The FCC limits the broadcast power of unlicensed stations like this to 0.1 watt. Eldoradio 1660 broadcasts 24/7 with a format that emphasizes calming music. The music is chosen randomly by alternating two CD changers of about 400 CDs. One changer is primarily classical, while the other is a mixture of jazz, pop, and folk music. Bill has spent 50 or more years in teaching, radio, and newspapers. He edited the arts page in Pasatiempo for the Santa Fe New Mexican in the 1970s, was program director at KSNM FM, Santa Fe's first FM station, and has taught English and speech in various grades as well as community college. He operates the station as a non-profit hobby, and the format is 98% music with an occasional public service announcement, weather bulletin, or Neighborhood Watch alert. I have been listening to his music for the last two days and have found the signal to be remarkably clear and the music to be both enjoyable and soothing. So when you have one of those stressful days and are within the Eldorado borders, try tuning in 1660 AM and relax. -Jim Daniel



# Western Meadowlark (WM)

have to credit **Dale Stahlecker** with spotting the Western Meadowlark in Eldorado. However, they are a common sight on the Marty Sanchez Golf Course during summer. They prefer open grassland and savannah areas. The WM is a chunky bird that usually flies close to the ground and sits on low trees, fences, etc. to sing its beautiful song. The WM has a wingspan of 14 inches and is 9.5 inches long. The breeding adults are similarly marked: a spotted brown and black back, a large white eye brow stripe, a very bright yellow neck, chest and belly, and a black Vshaped mark on its throat. They reach to Central America during the winter.

The male WM usually mates with two or more females and does little of the incubating or feeding of babies. He arrives early and vigorously sets up and defends his breeding territory. Alone, the female weaves a grass nest (which may have a top) on a depression in the ground. The female lays three to seven

eggs, incubates the eggs which hatch in 13 to 15 days, and the helpless young are ready to fledge in 12 days. Food consists of insects and seeds which they may pry out of the ground by inserting their strong bills.

To confuse things, we also see Eastern Meadowlarks, mostly in eastern New Mexico. The markings are almost identical, and the best way to tell the two apart is by their song. (I think the WM has a prettier song!) Some mixing does occur between the two species, but hybrids produce few eggs that hatch. The Western Meadowlark is the state bird of Kansas, Montana, Nebraska, North Dakota, Oregon, and Wyoming.

# El Dorado Community School Expansion

The 600-plus students at El Dorado Community School are the obvious beneficiaries of the new expansion and total makeover of the their kindergarten-through-8th-grade facility. A different kind of building was necessary when the 7th and 8th grade classes were added, says Principal Anne Darnton. In January 2011, the architectural drawings were approved, and the following May actual construction began.

Teachers and students had been relegated to small portable units until April 18 of this year, when they moved into the nearly complete "all new" learning environment. Jim Kirtland, Project Superintendent for McCarthy Construction and the lead on this project, says everything is new, right down to the desks and the state-of-theart technology.

Each classroom is quite spacious and has what is called a "smart board." Teachers have the capability (with only a laptop computer) to hook up to the super-sized computer screen on the wall and take the entire class to places all around the world without even leaving the building. Before the additions, sports teams had to practice somewhere else off campus. Now the brand-new gymnasium with shiny wood floors is the perfect environment for sports activities and physical education classes.

Only one-third of the original school remains, with the second floor for 5th through 8th grades added above it, says Kirtland. All other areas are new, including the cafeteria and kitchen. The students at the school think the most fascinating thing about their new campus is that it has a second floor—a staircase and an elevator probably the only elevator in Eldorado.

Children may be the big winners here, but all of Eldorado will come out on top. Many thanks to everyone who bought bonds through the 2009 sale to make this outstanding new 96,000-squarefoot learning facility a reality.
