To Build or Not to Build: That is the Conundrum

n three previous articles in Vistas (August, October, and November 2015) covering Eldorado Area Water and Sanitation District (EAWSD), we reviewed some of its history and some of its problems. Perhaps the most daunting of these challenges is its location—in the desert Southwest where water is not abundant. Yet there are other hurdles of note. In the mid-1990s, citizens in this community acted to form the District to gain local control over its water supply. As it's turning out, the road to "local control" can be a long and bumpy ride.

To obtain public ownership, the District found itself taking the drastic action of condemning the system—a move that stopped the developer from selling it to a Dutch conglomerate. One of the reasons cited for condemnation was Eldorado Utilities, Inc.'s lack of a permanent facility. The resulting adjudicated settlement of over \$11 million was awarded to the developer for its aging utility. The District scrambled to cover that inflated price through bond issuance totaling over \$13 million. Ever since acquiring the system, the District has worked under a significant debt.

The rate on those original bonds issued in 2004 was 6%. In June 2013, the District was successful in obtaining two loans (for \$4.7 and \$3.775 million) from the New Mexico Finance Authority with significantly lower interest rates. These loans were used to retire the original bonds. These loans are scheduled for retirement by 2023 and 2025.

The District's debt service is paid through revenues from water sales. Additional revenues come through property taxes on those living in the District. The District raised its rates in 2009 in order to maintain and add to the system. By early 2016, EAWSD water users can expect higher water bills resulting from the most recent of these raises. Users tied to the utility will also see a hike in their property taxes.

A HOME OF ITS OWN

Since its formation in 1997, EAWSD has managed its affairs from several venues. At first, the Board conducted its administrative business from a tiny office in the ECIA Community Center. Acquiring the utility in 2004 required larger quarters and the District

rented commercial space. When these offices became cramped, the District moved into the complex that was then called "The Village at Eldorado," where it is today.

In 2012, The Village went into foreclosure, resulting in the termination of the District's lease. The new and current owners, Steve Ewers and Destiny Allison, offered the District three options in writing: (1) sign a new lease, (2) buy the building (renamed La Tienda) at market value, or (3) rent the space month-to-month.

The District opted to rent month-to-month as a temporary solution toward finding a permanent space of its own, for both operations and administration. Back in 2010 the District had already received county approval for a development plan to build a combined office/maintenance facility on a 5.4 acre site at 190 Avenida Vista Grande, near Monte Alto Road. Preliminary drawings were rendered showing a 3,175 square foot maintenance facility (estimated at \$1.138 million) and a 5,000 square foot operations and administration building (estimated at \$1.14 million). Currently there is no funding for this facility, although the District has made efforts to obtain it.

In 2013, on its facility funding application to the NM Finance Authority, the District claimed that the landlords had been "unwilling to enter into a lease agreement." Then again, at a March 31, 2014, EAWSD public hearing, the District made the same claim. Ewers, feeling misrepresented, explained to EAWSD general manager David Chakroff that submitting an application to the Finance Authority with factually incorrect documents could result in losing the grant. Subsequently, the District submitted an amended "Technical Memorandum" with the application.

In an October 2014 letter to EAWSD president James Jenkins, Finance Authority CEO Robert P. Coalter responded to the District's amended technical memorandum: "Your letter focuses primarily on the circumstances surrounding EAWSD's submission of factually incorrect documents. . . . While this situation was a factor in the Finance's Authority's decision to terminate the binding commitment letter, staff, in its communication with your staff and counsel, have tried to emphasize that the decision was primarily financial."

Deck the Halls . . .

ith the holiday season upon us, many Eldorado residents will soon be decorating their homes for their family celebrations. While exterior holiday lighting is allowed in Eldorado, please remember that we do have guidelines for exterior lighting as part of the Guidelines for Protective Covenants and Building restrictions. These are detailed on page 8 of the Guidelines, and they are intended to prevent excessive glare and light pollution and to keep our night skies dark. These guidelines should be followed as closely as possible when putting up your exterior holiday lights. The link to the Lighting Guidelines in the Eldorado Website is as follows:

Some key points to remember when planning exterior decorating are:

- ▼ Avoid using any bright-colored spotlights or unshielded bulbs over 75 watts.
- ▼ Make sure that any larger lights (such as colored) spotlights) are shielded and aimed downward, not shining out toward your neighbors or up in the air.
- ▼ Consider putting a timer on exterior lights that will turn off your lights at a reasonable hour; this will save energy and keep you from bothering your neighbors in the late evening hours.
- ▼ Consider creative and reflective decorating! Not everything is about strands of lights. Reflective ornaments, ribbons, wreaths, garlands, and tinsel can be very attractive and use no electricity.
- ▼ Consider using energy-efficient LED holiday lights, wherever possible. They are now available at most stores that sell holiday lighting. LED holiday lights are:

-Efficient, saving up to 98% of the electricity needed to power conventional painted or ceramic coated bulbs:

- —Environmentally friendly, their low temperatures emitting less CO2, and their manufacture requiring no glass or tungsten (because electron movement in semiconductor chips is what causes illumination), also more environmentally friendly;
- -Durable, as LEDs are encased in hard-to-break plastic versus the more fragile glass of incandescent lights; also, being electronic, their lifetime is up to 10 years;
- —Practical, being available in standard packaging of 25- to 100-bulb strands that can be connected together to provide a seamless string;
- -Safe, being cool to the touch and much less likely to overload a circuit; and
- -Attractive, as they are available in traditional shapes, sizes, and colors.

Property Tax Clarified

ccording to David Chakroff, general manager of the EAWSD, the letter from Santa Fe County Treasurer Patrick Varela printed on the back page of the November Vistas did not make it clear which Eldorado residents would be affected by the announced tax increase. To clarify: Only properties within the Eldorado Area Water & Sanitation District will be affected.

Chakroff also writes, "The article implies that the tax mil levy was increased to 4.36 mils. That was the levy requested by the Board, but the State approved a tax levy of 4.246 mils. The new District tax levy is 4.246 mils. The article also states that the tax increase is expected to provide a revenue yield of \$1,199,000. That is not correct. The tax increase is expected to provide revenue yield of about \$260,000."

Message from the ECIA Board

The holidays are upon us, but your Association still has some tasks to wrap up before concluding a successful year. Our management company, HOAMCO, has identified finalists for the position of general manager, and we are currently holding interviews with them. We hope to have this process completed and a permanent GM in place at the beginning of the New Year.

We are also in the final stages of the budget process for 2016. A proposed budget has been reviewed by the Finance Committee and the Board, vetted at a public forum, and will be approved at the Board meeting on December 17. We are fully aware that Eldorado residents are being hit with increases in several major categories for the coming year, with higher property taxes, higher water rates, and expected increases in rates for electricity. Nonetheless, the expenses of the Association are also rising, and we continue to work toward building a solid reserve that will allow us to keep facilities in tip-top conditions in the future. We have sought to keep the annual assessment as low as possible and have instructed the general manager to work closely with members who face special financial needs.

With the year drawing to a close, we look back with satisfaction at the projects that have been completed during the past twelve months. The pool season this year was refreshing and fun as always! We have a new certified facilities manager and two after-hour building attendants who are available to assist Community Center users as well as keep the facilities safe and sound. In partnership with Santa Fe County, we completed repaving of the hike/bike trail from the school area to the Community Center. The Association completed maintenance on hike/bike segments on Avenida de Compadres and Avenida Casa de Oro. Major plantings were completed in the "triangle" area at the center's entrance. And we thank to the volunteers who worked diligently throughout the year on trails, landscaping, and other improvements. The goal of each of these projects has been to make our amenities more accessible and enjoyable for ECIA members. We hope everyone has a chance to enjoy the many recreational opportunities the ECIA has to offer.

And last but not least, we hope that everyone in Eldorado enjoys a safe and rewarding holiday season! -ECIA Board of Directors

Recent Board Actions

▼he ECIA Board held its regular monthly meeting on November 19, 2015. Six Board members were present: Dag Ryen (President, presiding), Pam Henline (Vice-President), Todd Handy (Treasurer), Jeanne Calzada (Interim Secretary), David Yard, and Antone Forneris. Director Greg Colello's absence was excused. President Ryen announced that a meeting open to all ECIA members would be held on December 7, at 7 PM in the Railroad Building to review the proposed ECIA budget for 2016. He also announced that State Senator Peter Wirth and State Representative Matthew McQueen will hold an open meeting in the Railroad Building on December 10, from 5:30 to 7 PM, to discuss state capital investments in the Eldorado area. The following formal actions were taken by unanimous vote.

- ▼A variance request was approved for a groundbased solar and thermal array located more than 15 feet from the dwelling with appropriate screening at 33 Altura Road.
- ▼ Variance requests were approved for a groundbased solar array located more than 15 feet from the dwelling with appropriate screening at 4 Carlito Road and at 8 Gavilan Road.

- A variance request was approved to allow for a 14foot-wide new portal with metal roof at 2 Monte
- ▼An amendment to the ECIA contract with HOAMCO was approved to include purchase of the Caliber software package for homeowner and Board communication at \$25/month.
- ▼ Motions were approved to appoint **Ken Kleiber** to the Road Committee and Ray Nichols to the Information Committee.

The following actions were also taken:

- ▼ A variance request for a small auxiliary structure (fish pond) at 114 Verano Loop was approved (Ryen, Calzada, Yard voting for; Henline, Forneris voting against; Handy abstaining).
- A variance request for approval of an existing fence line protruding into the 50-foot road frontage setback at 9 Bonito Court was rejected unanimously, with the Board requesting resubmission of the application to include additional information on enclosure square footage.

Regular Board meetings are scheduled on the third Thursday of each month at 7 PM at the Community Center and are open to the public. An open forum and community announcements are normally included. New-Old Radio Programs on Eldoradio

Tradition rules the airwaves on at least one small radio voice. Eldorado's low-power AM broadcaster, ELDO-RADIO 1660, adds a little touch of Christmas and Hanukkah music this Black Friday, increasing it slowly until December 24, when the 24-hour eclectic easylistening station will broadcast carols, concerti di natali, and holiday features all day for two days.

This year, ELDORADIO has added some new-old radio features, with more to come in 2016. Since November 1, Edward R. Murrow's five-minute "This I Believe" has aired at 7:30 AM seven days a week. Originally heard on CBS radio from 1950 to 1954, it follows "Good Morning, Eldorado" on at 7 AM every day.

Sundays at noon, manager Bill Dunning has presented occasional sneak previews of Retro Radio, a series starting regularly at noon Jan. 3. It will offer a full hour of old radio shows-comedy, mystery, dramatic and musical programs from 1930 to 1960, the Golden Age of Radio.

ELDORADIO also introduces this month a revolving 10:30 AM feature weekdays at "break time." These short programs highlight nuggets of history, storytelling, conversations, poetry, and comedy throughout the week.


The rest of the round-the-clock broadcast day is a blend of many different kinds of music, designed for tranquil relaxation, with only a few announcements now and then. Because of legal limitations, ELDORADIO, on the air since 2010, can only be heard within Eldorado.

Reel New Mexico in December

Screening on December 10 at 7 PM at La Tienda's Performance Space is Christmas in the Clouds (95 minutes, PG, 2001), part romantic comedy, part screwball comedy, and part historic breakthrough—the latter because the movie is about affluent Native American yuppies. Contrary to the typical Hollywood stereotypes of American Indians, this takes place at an upscale Indianowned ski resort. The only alcoholic in the cast is a white undercover investigator for a guidebook.

Kate Montgomery, the writer-director, has such affection for the characters (played by Sam Vlahos, Mari-Ana Tosca, Tim Vahle, and Graham Greene) that we can feel it through the screen; we sense they represent something she wants to say about the Native Americans she knows. Although the plot is perversely frustrating, the end of Christmas in the Clouds, after everything finally comes out more or less as we hoped it would, leaves us with surprising affection and warmth. There are holiday pictures that are more high-tech, more sensational, with bigger stars and higher budgets and even greater artistry, but there may not be many with such good cheer.

And you may not be aware that the library also has public computers with Internet and printing capabilities, a copy machine, public wi-fi, and a meeting room that can be reserved for groups. In addition, the library has many free programs for the community—check our website (www. vglibrary.org) or posted flyers for information. Computer use, printing, wi-fi, meeting room, and children's programs do not require a card, although VGPL is happy to issue cards to anyone in our service area.

Coalter's letter goes on to explain that since the District's application for the funding was more than a year old when its amended technical memorandum was resubmitted, the Authority's policy required a reevaluation of the applicant's financial picture: "The results of the financial review demonstrated a decline in pledged revenues from FY 2012, which were used to underwrite the loans and which provided coverage."

This fall, Ewers and Allison were dismayed when confronted by a resident asking, yet again, why they were refusing a lease to the District. In October 2015, the landlords notified the District that the month-tomonth rental agreement was no longer an option. Going forward, in order to stay in the building, the District would be required to sign a lease.

On November 2, 2015, the District was provided the terms of the lease that was to be signed by December 1. By the time of publication, the District will have either signed a multi-year lease with Ewers and Allison or it will be looking for other space from which to conduct its business. Local control over our water continues to bump along. - Gershon Siegel

Helping Out Our Roads

The Road Committee recently completed the fall inspections of all roads in Eldorado. And while the majority of them were found to be in good shape, washboarding on some of our dirt roads continues to be a problem. In some areas, the washboard will pop back up in just a week after the county road grader comes through. For those of you too young to know the origin of the word "washboard," a washboard surface on the road can best be described as the horizontal bumps and ruts that feel like a series of small speed bumps. At a minimum, driving on a washboard road surface is uncomfortable. In more extreme cases, it can increase the risk of skidding, damage the suspension system of your vehicle, and increase your maintenance costs.

What causes the washboard surface on a dirt road? A lack of moisture makes a road prone to a washboard surface, but the primary cause is our vehicles. As you drive your car, pickup truck, or SUV over the road, your tires lose a firm grip on the road and begin to spin or skid just a little, displacing a slight amount of gravel. After this is repeated a number of times, a series of ripples will begin to form and the washboard surface results. This is especially true at higher speeds and in areas of hard acceleration and braking, such as intersections or hilly areas.

You can help prevent washboard or at least delay its formation on your gravel or dirt road by following one simple rule: Slow down! Studies have shown that any traffic going over about 3 MPH is going to cause washboard eventually. Now, traveling at 3 MPH in a motorized vehicle isn't remotely practical or expected, but if you stay at or under the 25 MPH speed limit and go easy when you accelerate and brake, the washboard will form more slowly. And that's not the only benefit of slowing down; there will also be less dust, you will have more time to brake for wildlife crossing the road, and our roadways will be safer for our walkers and bicyclists. Let's all slow down for longer road life and a smoother, safer ride.

NEIGHBORHOOD WATCH FLORA & FAUNA GROUP Eldorado's Microclimates

or years, we've heard people say that one or another area of Eldorado has slightly different weather than a separate part of the community. Curious, we decided to investigate and found out that it's true! Eldorado is home to quite a few microclimates, defined as climates in a very small or restricted area, different from the climate of the surrounding area. How can this be?

Because the terrain in large parts of New Mexico's grasslands is not especially diverse, the climate in many areas is predictable. In contrast, Eldorado's terrain is significantly varied. The Rocky Mountains begin their uplift right at the north side of Eldorado and extend northward into Canada. We are sitting on the weathered run-off dirt that slopes from those mountains. This results in a difference in elevation of around 400 feet from the east side of Eldorado to the west end. That difference produces enough of a temperature variation to cause snow near Highway 285 while the west end of Vista Grande experiences cold rain.

The Rockies started developing 30 million years ago (and are still growing). Many peaks reach over 14,000 feet. Santa Fe's ski "hill" just to the east of the city sits at 12,000 feet. When rain falls on these mountains or snows melt, the downward-moving water picks up mineral particles and carries them along until they are dropped to settle on the soils beneath. Many of these run-offs of soil, called an alluvial fan, can be observed "fanning out" at the bottom on the narrow handle end in the mountains. You can see the

alluvial fan that we sit on if you look toward Eldorado when driving north over La Bajada on I-25.

In addition to elevation changes, microclimates can also be affected by location on or around hills. Since we are in the foothills of the Rockies, our land is hilly. The sun is more

intense on the south side of a hill and shadier and cooler on the north side. So, our microclimates are due to both elevation differences and varying exposure to solar radiation.

A reminder: With hunting season upon us, it's important to be very cautious around the open land (State Trust Land) at the far west end of Avenidas Eldorado and Vista Grande. Some of Eldorado's greenbelt trails go right up to the edge of the open land. Posted signs are outdated or in some cases nonexistent, but please be advised that the land is leased to a rancher and not open to the public except with permission. Due to hunting and trapping dangers, public access and use of the land is not encouraged.
