Minutes of the April 2022 Business Meeting Eldorado Stable Committee

Time and Place: The April 2022 Business Meeting of the Eldorado Stable Committee (ESC) was held on Monday, April 18 via Zoom and was called to order at 6:34 p.m. by the committee Chair, Amelia Adair. Total 2022 Operating Expenses for small projects originally requested by ESC = \$2500. Same amount requested \$2,800 requested due to increased cost for benches and other training equipment.

*ACTION ITEM: Inventory all training equipment at the Stables and propose a replacement plan if necessary for 2023. Ideally we'll change the way we handle replacement of old equipment, and consider it a replacement reserve expense with a minimal annual allowance when necessary, such as a \$1,500/year.

ESC Chair Report April 18, 2022

As usual, to save time, I'm submitting my chair report in writing. Please ask me any questions after the meeting, thanks!

1. Enforcement Status, Barns for Sale and Sharing.

- For Sale, Share & Vacant barns. Two barns are for sale (#s 14 and 34); one barn is available for share (#25), and four barns are presently vacant (5, 14, 25 and 29). Horses are due in to barn 5 before the end of April.
- **Spring Inspection**. Our annual Spring Stable inspection was held April 6, 2022. Approximately 12 barns had enforcement issues and received friendly reminder letters. Probably the least issues found at any inspection I have participated in.
- 2. <u>Water Leaks</u>. The last of several small, separate water leaks was found in the common line between the EASWD's meter and the ECIA's first shut off valves, and was fixed the end of March. The ECIA hired a plumber to fix it (not New Image), and the ECIA crew expanded the valve box with the shut off valves to make future repairs easier. The ECIA paid for all water not metered to individual barns. Note that the EASWD is raising everyone's water rates starting with the February billing cycle, which billed for January usage. This is part of the reason our water rates are now higher.

3. Project Report.

- **Drainage and road repair.** The materials for the drainage project have been purchased and delivered. Mike Rogers is still waiting on James A. Mason, Ph.D, P.E., ECIA Roads Committee Chair, to finish shooting the grades. The location of the line to the arroyo is already marked. Charli Stevens and Craig Geil kindly installed a temporary fence to protect the remaining open trench, until it is completed.
- Bank and Step Obstacle. Deena Joseph is working on a detailed plan and specifications for the project.
- **Planning for 2023 Projects**. Will happen this meeting and next. Notes from the ESC's spring walk-through the Stables is attached.
- Reserve Consultants. Deena and I walked the entire Stables with Zack Armijo, the ECIA's reserve consultant on March 29 as part of their every-other-year update of the ECIA's reserve study, which is used to determine what reserve and replacement projects need to be done, when, and what they are likely to cost. My understanding is the updated reserve study should be finished by July. An action item arising out of this walk is the need to inventory all the training equipment the ECIA owns or borrows, wherever stored or installed, around the Stables, and identify what needs replacement and when. Mr. Armijo suggested we establish a reasonable allowance as a replacement reserve, and felt the purchasing better quality equipment to replace old, failing equipment is not a

- capital expense but is in fact just upgrading, so falls as a reserve expense. Also of note, he confirmed that our new HDPE culverts and French drains, unlike old steel culverts, are considered lifetime investments, which will need maintenance but no replacement.
- Trail Course. The new bridge is completed and ready to install. Herb Seigel is leading that effort, and we've scheduled April 30 for a half day of refurbishing the trail course. Anyone interested in the reorganization of the trail course, please join us!
- **Electric box repair**. Several people reported the Tree Road outlet was not functioning. It has been repaired. The electrician found that live wires not attached to anything, buried in the ground near the new wire to that outlet, caused the new wire to short out. He traced and removed the old, live wire, and checked the other electrical panels to make sure we don't have that condition anywhere else.
- **Highway 285 Crossing**. I met with Mike Rogers about clearing a path from the Vista Grande crosswalk (which has an equestrian button) onto La Tienda property, when the crew does work on the monument. I also spoke to Jason Smith about whether we need any kind of permit for putting a pedestrian gate through the DOT's fence along 285.. We have an extra, unused 4 foot pedestrian gate in the upper equipment pen. Next step is to get back in touch with Steve and Destiny Ewers, owners of the property through which the trail would run, and confirm they're still OK with us crossing their property, and removing downed barbed wire fence near the monument to provide safe access to the crosswalk. The gate will need to be chained and kept locked with a padlock with our combination code, so a mounting block will be necessary on the outside of the gate.

4. Activities around the Stables.

- The annual **Spring Manure Loading Day** for gardeners took place April 13. We had at least 5 people come fill trucks or trailers. Advertising for this event in the Vistas also resulted in an increase in gardeners calling our hotline and sending emails about self-serving manure.
- Our first **Wine and Weeds Walk** will be the third Saturday evening in May. Mark your calendars.
- 5. <u>Risk Management</u>. **DialMyCalls Test**. After the Emergency Preparedness Plan is updated, we'll finalize the Roster and test a broadcast text message via DialMyCalls, reminding everyone to read the updated Plan, now looking like May since we made some final changes in the Emergency plan at our March meeting.

Footing is MUCH improved in all arenas, considering we had a major snowfall last night, and it's already OK to use this afternoon. Discussed importance of maintaining the drainage out and away from these areas. Discussed the plan to remove (and stockpile) some footing from the UA to see if reducing the depth of footing works to further prolong the life of the footing Deena explained that CM Footing has recommended replacement of the UA footing, but the TR3 may prolong its life. It's expensive to replace, but improved footing should be more resilient and not feel so deep.
