Minutes of the June 2022 Business Meeting Eldorado Stable Committee

Time and Place: The June 2022 Business Meeting of the Eldorado Stable Committee (ESC) was held on Monday, June 20 via Zoom and was called to order at 6:33 p.m. by the departing committee Chair, Amelia Adair. Amelia was elected to the ECIA Board and will serve as Vice President and Stable Liaison. Going forward the Stable Committee will operate with members rotating as meeting chair and assuming Amelia's responsibilities, which were divided up among them. Nominations to join the committee are still open.

Copies of the *May agenda; April ESC Minutes; 2022 Budget Request and the Chair Report* were emailed to the entire stable community prior to the meeting and available to all participants. **Please reference the Chair Report for the full scope of Stable Initiatives in earlier stages of completion and not discussed at the meeting** The meeting was recorded.

Quorum, Attendees: A quorum of ESC members was present, specifically Amelia Adair, Deena Joseph, Lisa Bessone and Kelly Smith. Liz Matthews had an excused absence. In addition to ESC Members, ECIA Staff members present included Administrative Assistant Ciera Walsh and Jocelyn Rizo, Administrative Assistant, Operations and Compliance. The following Stable community members were present: Carol Loewy, Karla Lauritsen, and Frank and Mechele Tadeo. Paul Butt of the Conservation Committee was also in attendance. Lisa Bessone served as interim Secretary.

Motions:

- The June Agenda was approved
- The May ESC Meeting Minutes were approved
- Approval of the amended 2023 ESC budget, after review by the stable community, carried unanimously
- Amended Emergency Equine Intake Plan passed and ready for Board review
- Motion passed recognizing the Stable committee's division of responsibilities (see above)
- The meeting was adjourned at 8:20 p.m.

New Business:

- Amelia formerly resigned as chair due to her new Board assignment.
- Call for nominations to the stable produced no volunteers; discussion ensued recognizing that opportunities for involvement in stable projects exist without joining the committee
- Initial discussion on stable events including a July workday, Summer Pot Luck, Community Day and reviving a former imitative – Artists Day. Committee to lead and recruit volunteers to assist

- Deena Joseph reported on meeting with CM Footing consultants on the three arenas and progress with the new equipment
- ECIA Report
 - Assistant General Manager Jessica Collins has resigned from her duties to accept a new position with HOMACO closer to her home. Ciara and Jocelyn will transition to oversee Jessica's stable responsibilities.
 - Office still awaiting legal approval that interactive form on ECIA Website is permissible for signing liability releases and acknowledgement that new barnowners have read and agree to the rules
 - o The July 4 Parade to honor Eldorado's 50th anniversary celebration
 - The drainage project will cross the Red Barn Road and may disrupt traffic, both horse and auto, for a day or so this month

ELDORADO COMMUNITY STABLES

New Stable Amenity Rule, Section IV(F) Temporary Evacuees

Version dated 6/27/22 – Motion to approve this rule adopted at the ESC Meeting on 6/20/22, subject to numbering the Rule

The Eldorado Community Stables does not have the capacity to be an emergency evacuation site but strives to be a compassionate neighbor. If an individual barn owner with unoccupied space and shelter would like to offer a safe haven to an evacuee through the duration of an evacuation order, they may do so under these conditions and with these exceptions:

- The current Stable Rule V(I) rule prohibiting overnight guest horses is waived
- Barn owners must provide the ECIA office with this paperwork for evacuees
 - The New Horse Application Form
 - Guest Horse Waiver and Information Form
 - o Equestrian Liability and Waiver and Release Agreement
- The maximum number of equines in any barn remains four
- Coggins and health certificates are waived for horses sheltering in the amenity during an emergency, except for out-of-state equines
- Evacuees, however, may not leave the host barn to use the Stable common areas until the ECIA office receives paperwork including a negative Coggins and health certificate
- Evacuated horses are welcome to use the public facilities, such as arenas, round pens and roads, after all required health paperwork has been provided to the ECIA office
- Barn owner will incur manure and water charges for any additional equines

ESC Chair Report June 16, 2022

As usual, to save time, I'm submitting my chair report in writing. Please ask me any questions after the meeting, thanks!

1. Enforcement Status, Barns for Sale and Sharing.

- For Sale, Share & Vacant barns. Two barns are for sale (#s 14 and 34); one barn is available for share (#25), and Four barns are presently vacant (5, 14, 25 and 29). Both barns #5 and 25 have asked their neighbors to turn horses out in them to help graze down weeds.
- 2. <u>Invasive Weeds</u>. The maintenance crew is testing sprays of vinegar and dish soap vs. an organic weed killer, "Avenger". Depending on which of those sprays works best, the crew will continue to spray the hoary cress infestation near the Stable gate. We should all make sure to pull and bag any hoary cress we see; it will likely take several years of diligent effort to eradicate. It may be toxic to horses, so be careful not to allow your horses to graze on it. Fencing will be removed at the test sites this Wednesday, 6/22. Mowing between paddocks will also be done this Wednesday 6/22.
- 3. Project Report.
 - **Drainage and road repair.** The drainage project is completed other than the area where the drainpipes meet at the fence at by the Red Barn. The maintenance crew is still working on connecting the drain from where the field by the Red Barn drains onto our side of the fence. The project should be completed before the end of June.
 - Bank and Step Obstacle. Deena Joseph is working on a detailed plan and specifications for the project.
 - Trail Course. The new bridge is completed and in place. We're now ready to schedule a trail course work day to reorganize the moveable obstacles. Thank you to Herb Seigel who built the bridge, and to Mike Ault, Martin Adair, Gordon Smith and Dina Seigel who helped deliver and install it.
 - Highway 285 Crossing. The maintenance crew has improved the waiting area at the equestrian crossing of
 Highway 285 and Avenida Vista Grande, and removed downed fence. I will continue working on the gates
 through the La Tienda property, to provide safe, off-road access to the crossing.
- 4. <u>Activities around the Stables</u>. Our second **Wine and Weeds Walk** is set for June 25 at 5:30 pm. The July 4 parade is on, line up begins at 9:00 am on Moya Rd., parade begins at 10:00 am along Avenida Torreon to the Community Center. Planning for the summer potluck, Community Day and other potential activities is slated for our June agenda.
- 5. <u>Stable Financial & Budget Issues</u>. At the last Finance Committee (FC) meeting, the FC discussed the issue of categorizing the new package of Coyote jump standards that we had asked to purchase last year. Since the cost is so close to the \$1,500 threshold, last year past President Sal Monaco did not approve the purchase, wanting us to seek approval of the purchase as a capital improvement expense. The reserve consultant recommended we consider asking the FC to consider an allowance for smaller replacement reserve items such as the jump standards. However, Board treasurer Joseph Gutierrez believes the \$1,500 threshold for smaller items coming out of the operating budget makes sense, and asked us to work with general manager Julie Navarro to get that purchase done.

The FC also confirmed a change to the annual budget schedule for all committees, so budget requests, including operating, capital and reserve projects, must be submitted to the GM by July 8. We will be on time for that schedule, as we've been working on our budget requests over the last couple of months.
