- ☑ Herrada Terrace Greenbelt Access trail update: trail from trestle underpass up to main social trail was rerouted, approx 500', by HOAMCO maintenance. Comments received so far have been positive. The TR3 "Arena Drag" tool purchased for the stables was used, and the job only took about 4 hours.
- 9. Project status updates:
- ② Fuels Reduction in Greenbelts, neighborhood organization. Thom Bredenberg toured parts of Gallina Park with Mike Schneider. There are a few small areas where the tumbleweeds are pretty thick, but otherwise, the heavy proliferation of cow-pen daisies this year appears to have suppressed the tumbleweeds.
- ② Pueblo Cañon Park survey. Paul Butt showed the draft "Request for Bids" (RFB) to his GIS instructor @ CNM and has made updates according to his instructor's recommendations. The specifications are now in terms commonly used by surveyors, and some unnecessary items have been removed.
- o Paul is working with Mike Rogers on an unrelated project to have the Greenbelt access point at Herrada Terrace surveyed, with the property lines on either to be clearly demarcated by the surveyor. This is necessary in order to ensure that the Greenbelt access trail to be constructed from the end of Herrada Terrace down to the trail in the Los Alamos Park greenbelt stays within the Greenbelt boundaries.

POLICY TITLE: ECIA POLICY FOR MANAGEMENT PRIORITIES FOR THE

ELDORADO FLOODPLAIN EASEMENTS (GREENBELTS)

<b>BOARD POLICY NUMBER:</b>	
DATE OF POLICY:	

The Eldorado "Greenbelts" are floodplain easements. Management goals for the Greenbelts are to protect, maintain and enhance their functions as floodplains while conserving their values including wildlife habitat and preservation of the natural viewscape.

The Greenbelts' capacity for retaining floodwater is critically important for adjacent and down-slope properties. Therefore, management priorities for the Greenbelts are to preserve them from damage resulting from clearing, grading or dumping of earth, waste material, etc.

Notwithstanding these priorities, wildfire risk within Eldorado is a factor influencing

the management of the subdivision's common areas, including the Greenbelts.

There are over three times as many acres of private property within the subdivision as there are acres of greenbelts and private property is where wildfire risk mitigation efforts should be focused.

The Board strongly recommends that concerned residents avail themselves of the information resources provided by the Santa Fe County Wildland Fire Division, regarding the development and maintenance of "defensible space" around their homes and other buildings.

Over time, dead vegetation may accumulate in specific locations within the Greenbelts. In order to reduce the risk of serious wildfire occurring within the Greenbelts, when an Eldorado resident who is a Member in Good Standing identifies an area with a perceived fuel accumulation hazard, they may report it for action to the ECIA Property Management contractor's administrative office (HOAMCO).

The Property Management contractor's maintenance staff shall apply the Standard Operating Procedure (attached and herein incorporated by reference) for identifying and removing hazardous fuel accumulations from the Greenbelts.
