### ECIA Standing Committees:

- ☐ **Architecture:** The mission of Architecture Committee (AC) is to support the ECIA Board in implementing the Amended and Restated Protective Covenants and Building Restrictions for Eldorado at Santa Fe (Covenants) and Guidelines for Protective Covenants and Building Restrictions for Eldorado at Santa Fe (Guidelines) as residents and developers submit plans for the construction, addition or remodeling of dwellings and other structures covered under the covenants and guidelines.
- ☐ **Bylaws Review:** The mission of the Bylaws Review Committee is to solicit input from all Association Members for comments and suggestions regarding the current Bylaws for ECIA; assess the existing ECIA bylaws as they related to Members' input along with Association challenges and opportunities; and if existing bylaws are deemed to require an update, create a new amended version and shepherd it through the approval process up to the point of voting by the Association.
- ☐ **Conservation:** The mission of the Conservation Committee is to advise, assist and recommend to the ECIA Board actions to protect the existing natural resources of the community and enhance these resources whenever possible, to provide recreational opportunities for the community in the use of these natural resources, and to offer a variety of opportunities for resource education.
- ☐ **Election:** The mission of the Election Committee is to: conduct and ensure the fairness and integrity of any ECIA election process; confirm a quorum of Members has been met for the Annual Meeting of Members, in accordance with the ECIA Bylaws; and fulfill all provisions delineated in the ECIA Election Procedures; maintain the principles of openness and transparency in support of the ECIA governing documents.
- ☐ **Facilities and Grounds:** The mission of the Facilities and Grounds (F&G) Committee is to advise, assist, and make recommendations to the ECIA Board as the voice of the residents regarding ECIA amenities. F&G recommendations will reflect good stewardship principles, policies and long-range planning for maintenance and improvement of ECIA facilities and grounds while balancing the needs of the community with available financial resources.
- ☐ **Finance:** The Finance Committee serves the community by providing the ECIA Board with recommendations on financial planning. The Committee makes recommendations to the Board and advises them on the annual budget and compliance monitoring, investment review, proposed capital expenditures, maintenance of a Replacement Reserve, long-range financial planning and analysis, and development of financial policies and procedures and advises regarding adherence.
- ☐ **Road:** The mission of the Road Committee is to advise, assist and recommend to the ECIA Board policies involving the improvement, maintenance and repair of roads in Eldorado. Roads are owned and maintained by Santa Fe County.

- ☐ **Stable:** The mission of the Eldorado Stable Committee (ESC) is to advise, assist and recommend to the ECIA Board of Directors on matters related to the ECIA stable amenity.
- ☐ **Volunteer Recruitment and Retention:** The VRRRC's mission is to continuously improve the quality of the ECIA's volunteer leadership by attracting, supporting and helping retain volunteers for ECIA committees, task forces, events and special projects, and Board nominees. This committee is working on improvements in welcoming new residents and supporting community outreach events.

Currently active task forces:

- ☐ **Covenant Compliance Policy Update:** Review and suggest revisions to the ECIA's Covenant Compliance Policy.
- ☐ **GIS Mapping:** working with Santa Fe County to develop a GIS tool that will help identify ECIA property lines, easement boundaries and County assets like culverts and major trees.
- ☐ **Safety Education:** help educate the community about fire safety and work with the Santa Fe County Sheriff.
- ☐ **Website:** Redesign of the new ECIA website.
